FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 4 in Block 28 of the Lands of the Riverside Land & Irrigating Company, as shown by map on file in Book 1, page 70 of Maps, records of San Bernardino County, California, more particularly described as follows:

BEGINNING at the most westerly corner of said Lot;

THENCE North 56° 00' 00" East, along the northwesterly line of said Lot a distance of 364.20 feet to the most northerly corner of that certain parcel of land conveyed to Hyrosen Properties, Inc., by a deed recorded June 13, 1978, as Instrument No. 119838 of Official Records of Riverside County;

THENCE South 34° 00' 00" East, along the northeasterly line of said parcel a distance of 4.00 feet to a line which is parallel with and distant 4.00 feet southeasterly as measured at right angle from said northwesterly line;

THENCE South 56° 00' 00" West, along said parallel line 293.29 feet to the beginning of a non-tangent curve with a radius of 140.00 feet and concaving southeasterly; the radial line of said non-tangent curve at said beginning bears North 43° 41' 47" West;

THENCE Southwesterly along said non-tangent curve an arc length of 21.05 feet, thru a central angle of 8° 37' 00" to the beginning of a compound curve with a radius of 40.00 feet and concaving easterly; the radial line of said compound curve at said beginning bears North 52° 18' 47" West;

THENCE Southwesterly along said compound curve an arc length of 37.27 feet, thru a central angle of 53° 22' 55" to the beginning of a compound curve with a radius of 140.00 feet and concaving easterly;

THENCE Southeasterly along last mentioned compound curve an arc length of 44.75 feet, thru a central angle 18° 18' 47" to the beginning of a reverse curve with a radius of 120.00 feet and concaving southwesterly;

THENCE Southeasterly along said reverse curve an arc length of 27.75 feet, thru a central angle of 13° 15' 00" to the end thereof;

THENCE South 17° 37' 24" East, 38.31 feet to a line which is parallel with and distant 4.00 feet northeasterly as measured at right angle from the southwesterly line of said Lot;

THENCE South 34° 00' 29" East, along said parallel line 60.23 feet to the northwesterly right of way line of the Atchinson, Topeka & Santa Fe Railroad;

THENCE South 67° 33' 30" West, along said northwesterly line 4.08 feet to said southwesterly line of Lot 4;

THENCE North 34° 00' 29" West, along said southwesterly line 202.16 feet to the point of beginning.



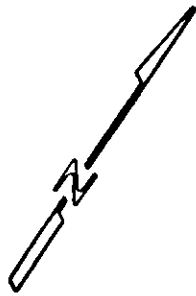
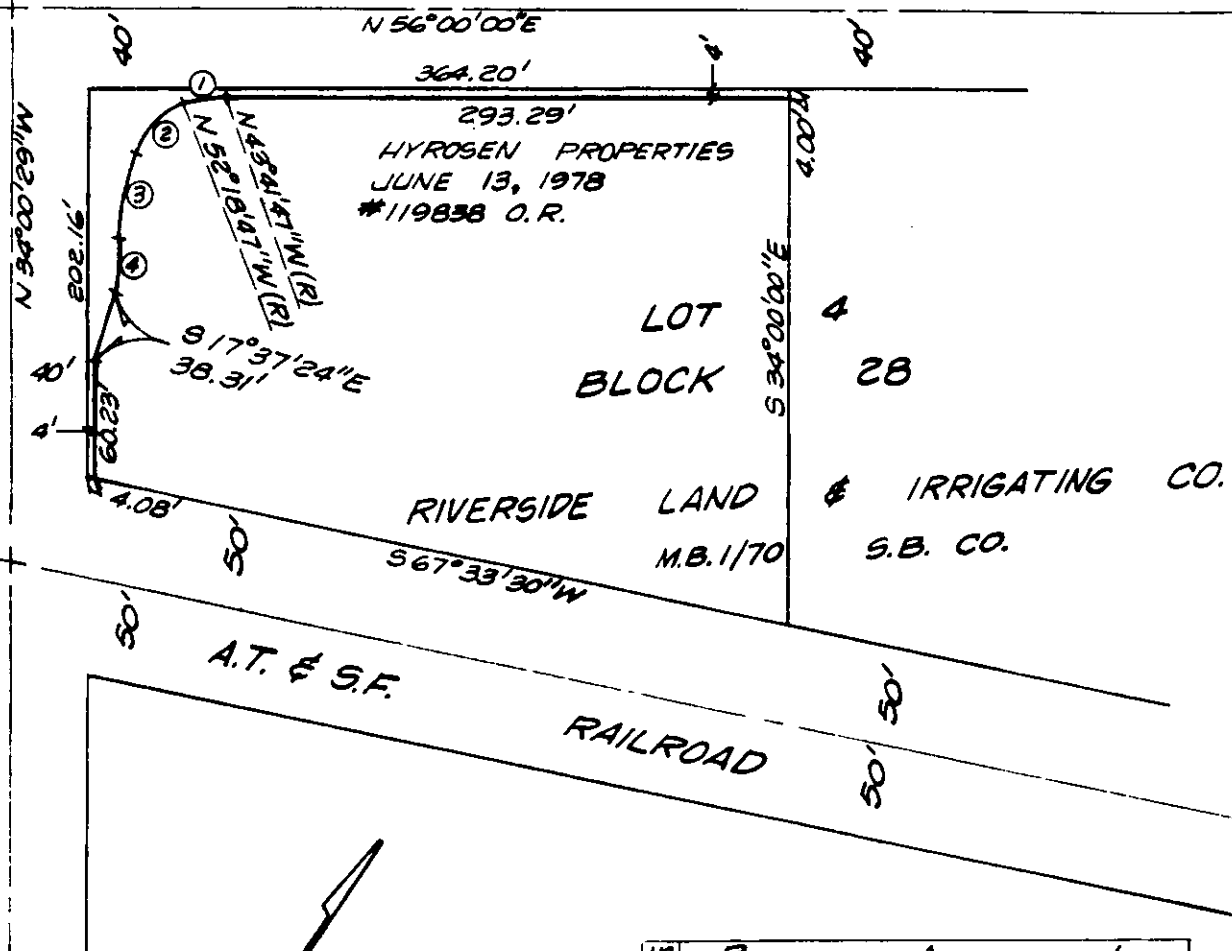
