FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do es hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 42 in Block 12 of the Village of Arlington as shown by map on file in Book 1, Page 62 of Maps, records of San Bernardino County, California, described as follows:

BEGINNING at a point in the Easterly line of Van Buren Boulevard (formerly Van Buren Street) distant thereon 600 feet southerly from the southerly line of California Avenue as said streets are shown on said map of the Village of Arlington;

THENCE continuing Southerly, along said easterly line of Van Buren Boulevard, 350 feet;

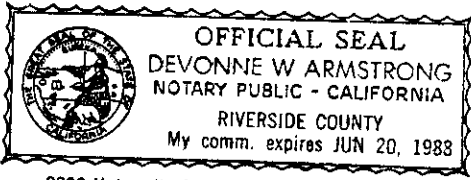

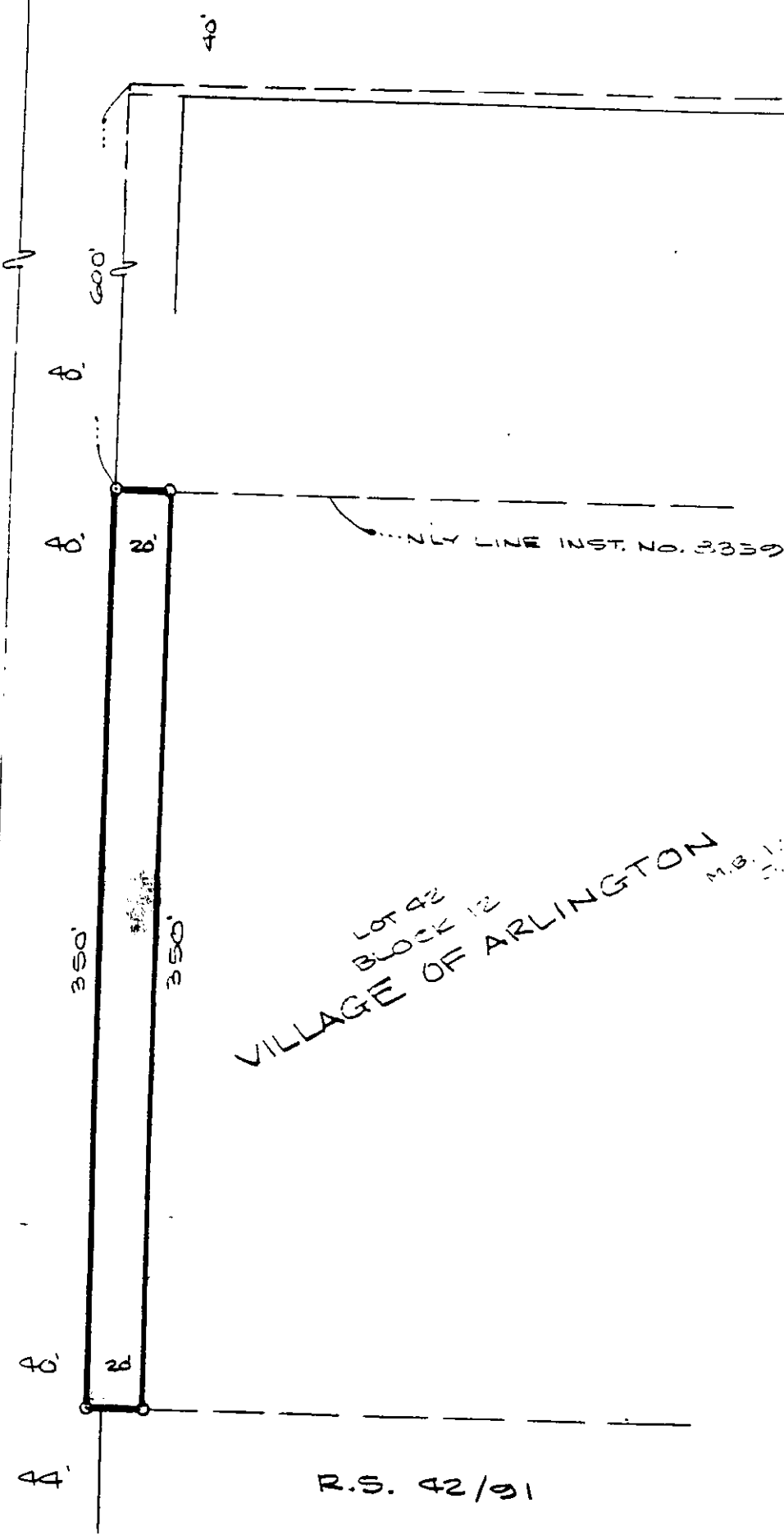
