E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, MCKINLEY VILLAGE, a joint venture, as Grantor, grants to the CITY OF RIVERSIDE, a municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of waterline facilities together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Corona, County of Riverside, State of California, described as follows:

PARCEL 1

LOTS A THROUGH E, AND LOTS J THROUGH N INCLUSIVE OF TRACT 19383-1, AS SHOWN BY MAP ON FILE IN BOOK 147 OF MAPS AT PAGE 62 THEREOF, RECORDS OF RIVERSIDE COUNTY CALIFORNIA.

THENCE NORTHEASTERLY, NORTHERLY, AND NORTHWESTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 18° 12' 35" AN ARC LENGTH OF 5.09 FEET;

THENCE NORTH 34° 03' 10" WEST ALONG SAID SOUTHWESTERLY LINE 5.00 FEET TO THE TRUE POINT OF BEGINNING;

THENCE NORTH 22° 43' 00" WEST 6.00 FEET;

THENCE NORTH 67° 17' 00" EAST 10.00 FEET;

THENCE SOUTH 22° 43' 00" EAST 6.00 FEET TO THE NORTHWESTERLY LINE OF SAID LOT B;

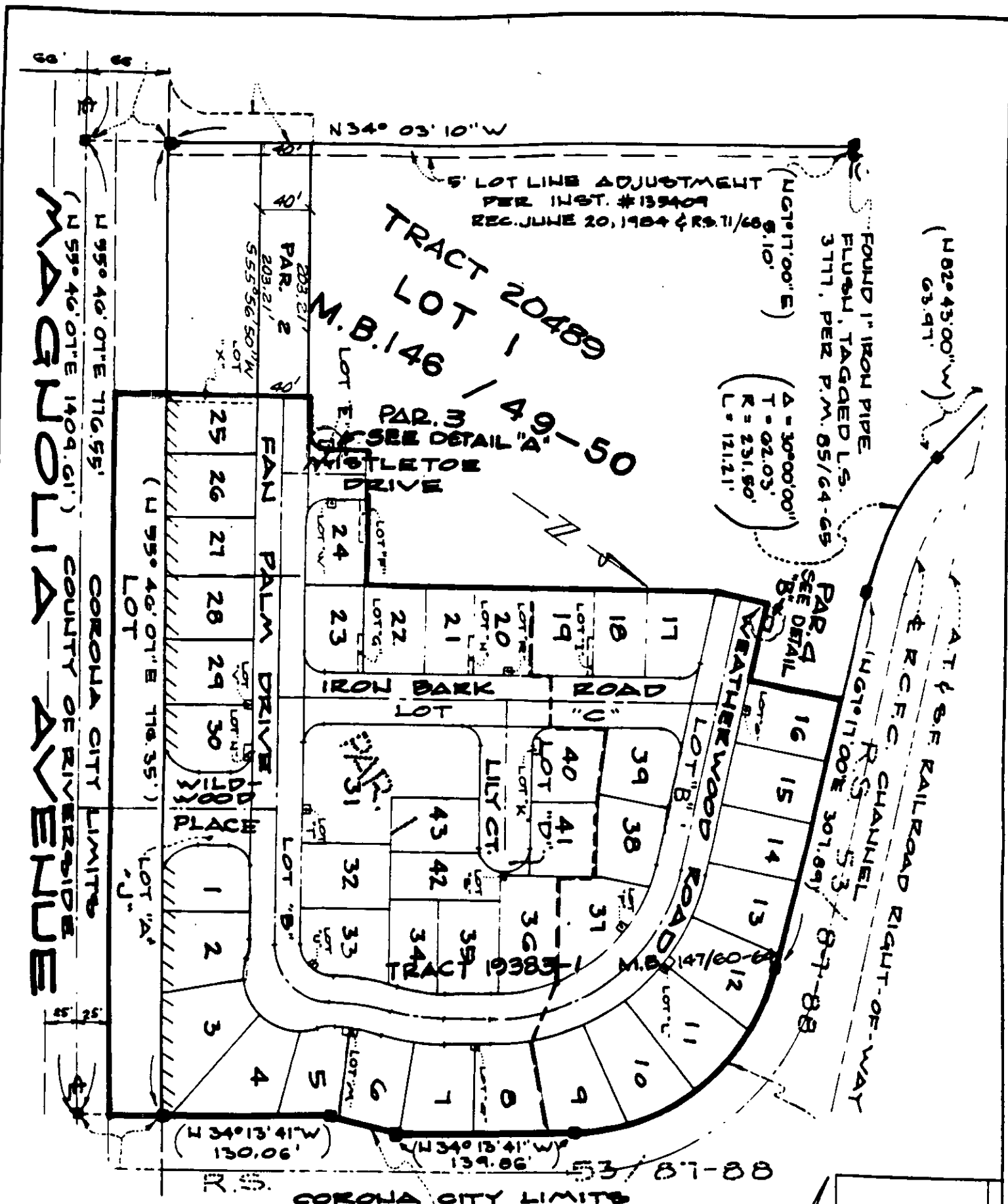

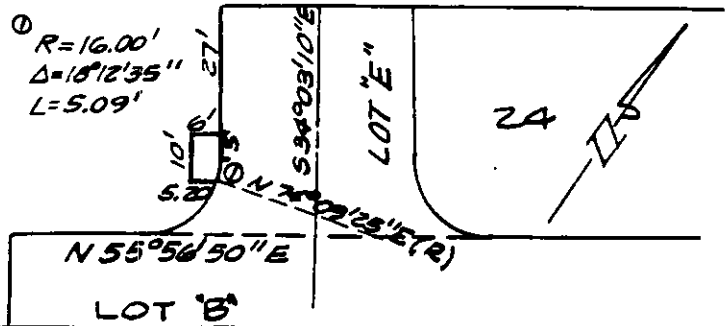

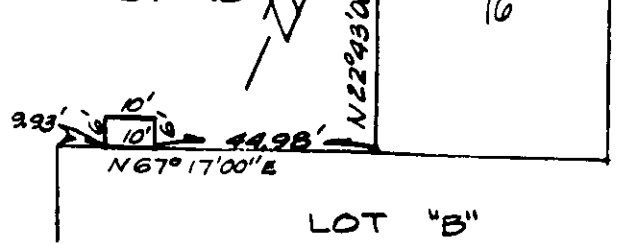
