A RESOLUTION OF THE CITY COUNCIL OF THE CITY RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 5657 AND TRACT NO. 9419-1 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 19063) FOR STREET PURPOSES TO BE KNOWN AS A PORTION OF CENTURY AVENUE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as a portion of Century Avenue:

Parcel 2:



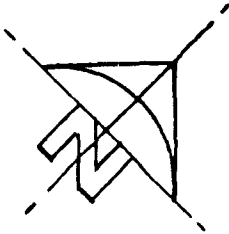
