RESOLUTION NO. 15997

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING FOR PUBLIC STREET PURPOSES PORTIONS OF ESSEX STREET AND CHESTER STREET (FORMERLY KNOWN AS DEXTER STREET) SOUTHERLY OF JURUPA AVENUE OFFERED FOR DEDICATION BY TRACT NO. 1 OF THE RIVERVIEW ADDITION TO THE CITY OF RIVERSIDE FILED IN THE OFFICE OF THE RECORDER OF THE COUNTY OF RIVERSIDE ON AUGUST 8, 1908.

WHEREAS in connection with Tract No. 1 of the Riverview Addition to the City of Riverside, certain streets and alleys as shown on the map thereof were dedicated to the public; and

WHEREAS the City Council of the City of Riverside now desires to accept portions of Essex Street and Chester Street (formerly known as Dexter Street) southerly of Jurupa Avenue offered for dedication by the map for said Grant No. 1 of the Riverview Addition;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

1. That the hereinafter described portions of property irrevocably offered for dedication to the City of Riverside by the subdivision map of Tract No. 1 of the Riverview Addition to the City of Riverside, filed in the office of the Recorder of the County of Riverside on August 8, 1908, are hereby accepted by the City of Riverside for street purposes to become and be known as portions of Essex Street and Chester Street, respectively, together with all rights to construct and maintain therein utilities, sewers, drains and other improvements consistent with said use as a public street. 8 Portion of Chester Street:


9 All that portion of Chester Street (formerly Dexter
10 Street) lying between Blocks 26 and 27 of Tract No. 1 of
11 the Riverview Addition to the City of Riverside as shown
12 by map on file in Book 6, Page 38 of Maps, records of
13 Riverside County, California, and lying northerly of the
14 westerly prolongation of the southerly line of Lot 14 in
15 said Block 26.

13 2. That the City Clerk is authorized and directed to
14 cause a certified copy of this resolution to be recorded in the
15 office of the County Recorder of Riverside County, California.

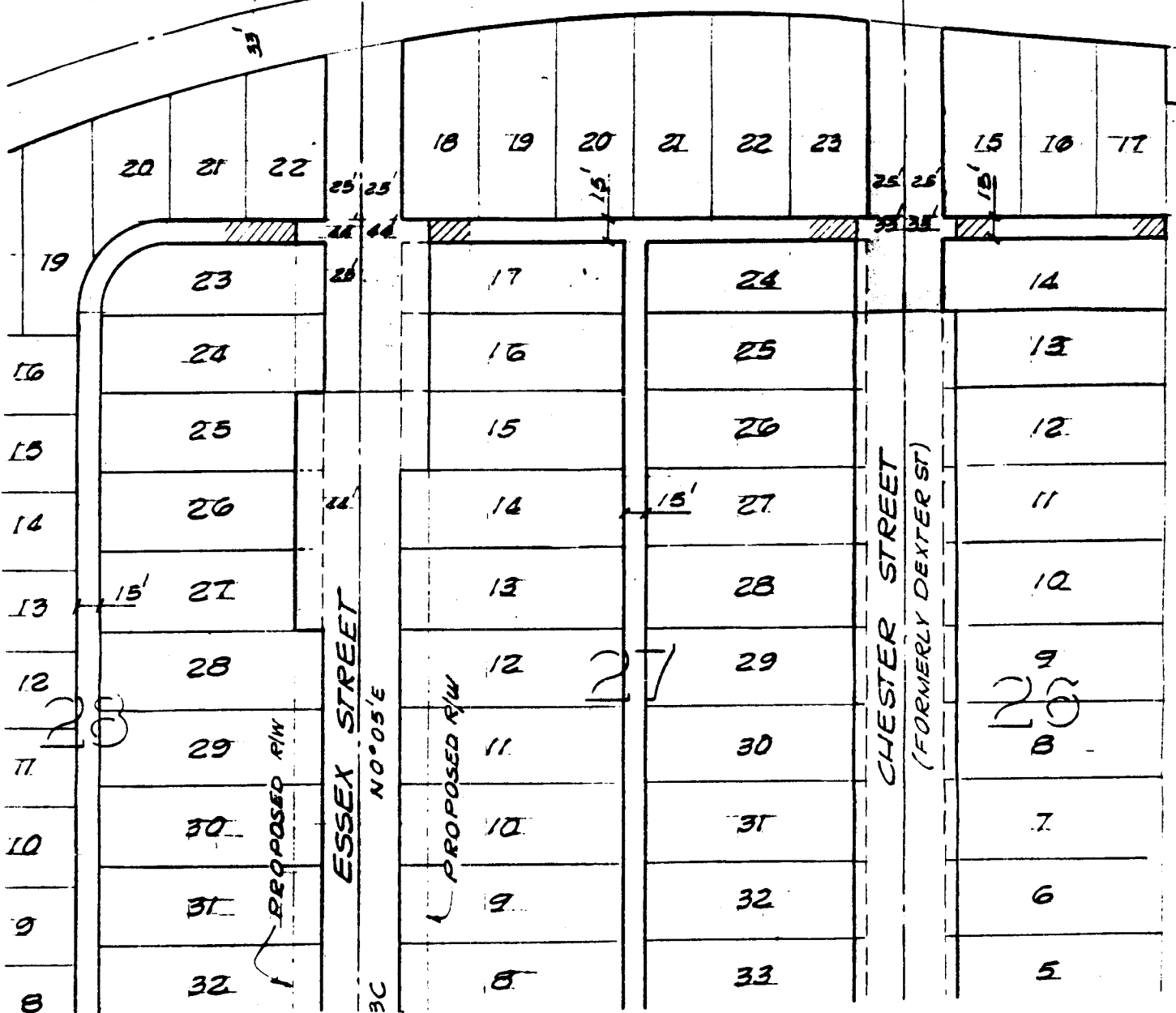
