BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside, that the name of Osborn Lane, a short cul-de-sac street extending southerly from Victoria Avenue, located easterly of La Sierra Avenue and northerly of Cleveland Avenue, and described as follows:

Lots B, C, D and E (Osborn Lane) of Parcel Map No. 9026 as shown by map on file in Book 60, Page 15 of Parcels Maps, records of Riverside County, California;

be changed to MILLSWEET PLACE.

BE IT FURTHER RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside, that the name of a portion of Kayjay Street extending northerly from Cleveland Avenue, located easterly of La Sierra Avenue and southerly of Victoria Avenue, and described as follows:

Lot C (Kayjay Street) of Tract No. 9991, as shown by map on file in Book 103, Pages 89 through 91 of Maps, records of said Riverside County, together with that portion of Lot C (Kayjay Street) of Tract No. 15555-1, as shown by map on file in Book 140, Pages 34 through 36 of Maps, records of said Riverside County, lying southeasterly of the northeasterly prolongation of the northwesterly line of said Lot C of Tract No. 9991;

be changed to VILLA FRANCA STREET.
