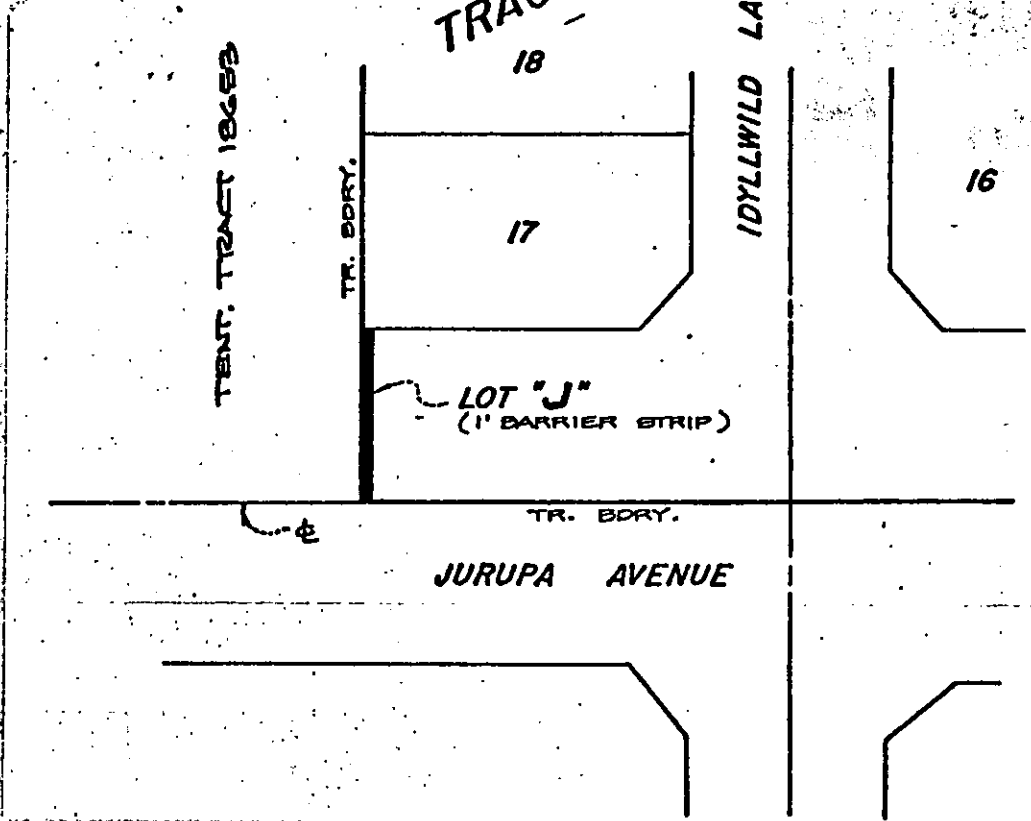
LOT "E"
