GRANT DEED

CONCORDIA DEVELOPMENT CORPORATION, a California corporation, Grantor, FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a municipal corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Blocks 14, 15, 16 and 17, together with that portion of Lot I (Simmons Avenue), Lot AA (Pingree Avenue) and Lot II (Simmons Avenue) of La Sierra Gardens, on file in Book 11, Pages 42 through 50 of Maps, records of said Riverside County, described as follows:

COMMENCING at the intersection of the southeasterly right-of-way line of the La Sierra Storm Drain Channel, as shown by Record of Survey on file in Book 34 of Record of Surveys, at Pages 3 through 6 thereof, records of said Riverside County, with the centerline of Golden Avenue (vacated), as shown by said map of La Sierra Gardens;

THENCE South 22° 38' 30" West, along said storm drain channel right-of-way, a distance of 788.36 feet to the TRUE POINT OF BEGINNING;

THENCE South 67° 21' 30" East, a distance of 470.35 feet;

THENCE South 34° 00' 05" East, a distance of 326.69 feet;

THENCE South 55° 59' 55" West, a distance of 200.93 feet to the beginning of a tangent curve, concave northerly, having a radius of 247.00 feet;

THENCE westerly along said curve having a radius of 247.00 feet through a central angle of 56° 38' 35", an arc length of 244.19 feet;

THENCE North 67° 21' 30" West, a distance of 200.97 feet to the beginning of a tangent curve, concave northerly, having a radius of 87.00 feet;

THENCE westerly along said curve having a radius of 87.00 feet through a central angle of 10° 00' 00", an arc length of 15.18 feet;

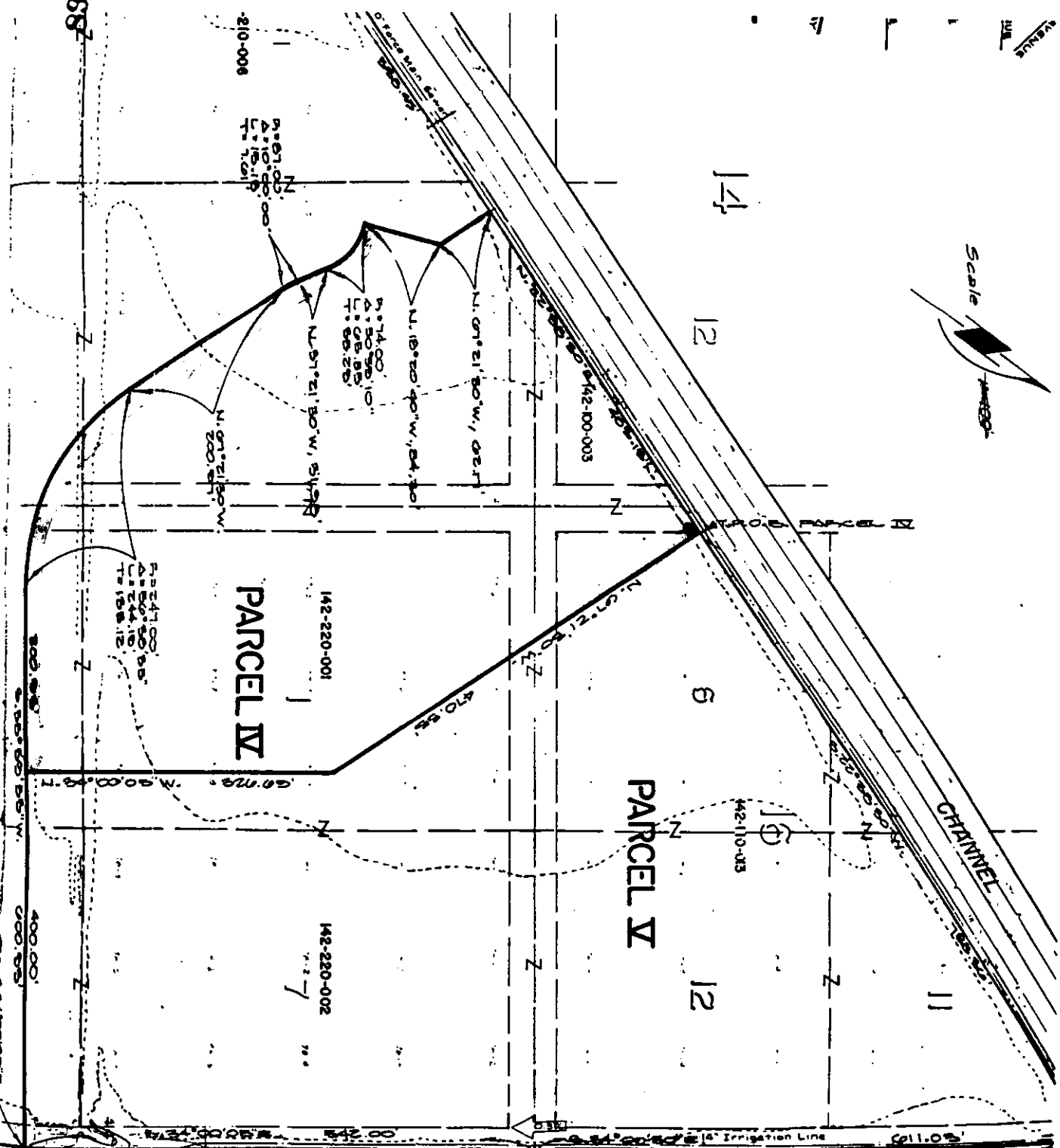
