A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 9078-4, TRACT 9078-5 AND TRACT NO. 9078-6 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 9078) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF CANYON CREST DRIVE, GREYSTONE DRIVE AND WILDING PLACE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Canyon Crest Drive, Greystone Drive and Wilding Place:

Lot "N" (1' barrier strip) of Tract No. 9078-4, as shown by map on file in Book 148 of Maps, at Pages 55 through 58 thereof, records of Riverside County, California.

EXCEPTING therefrom the southwesterly 25.00 feet thereof.

Lot "D" (1' barrier strip) of Tract No. 9078-5, as shown by map on file in Book 151 of Maps, at Pages 76 and 77 thereof, records of Riverside County, California.

EXCEPTING therefrom that portion lying northerly of the northerly terminus of that course shown as having a radius of 1600.00 feet and central angle of 22° 18' 35" an arc length of 623.01 feet.

Lots "G", "H" and "J" (1' barrier strips) of Tract No. 9078-6, as shown by map on file in Book 156 of Maps, at Pages 58 through 60 thereof, records of Riverside County, California.

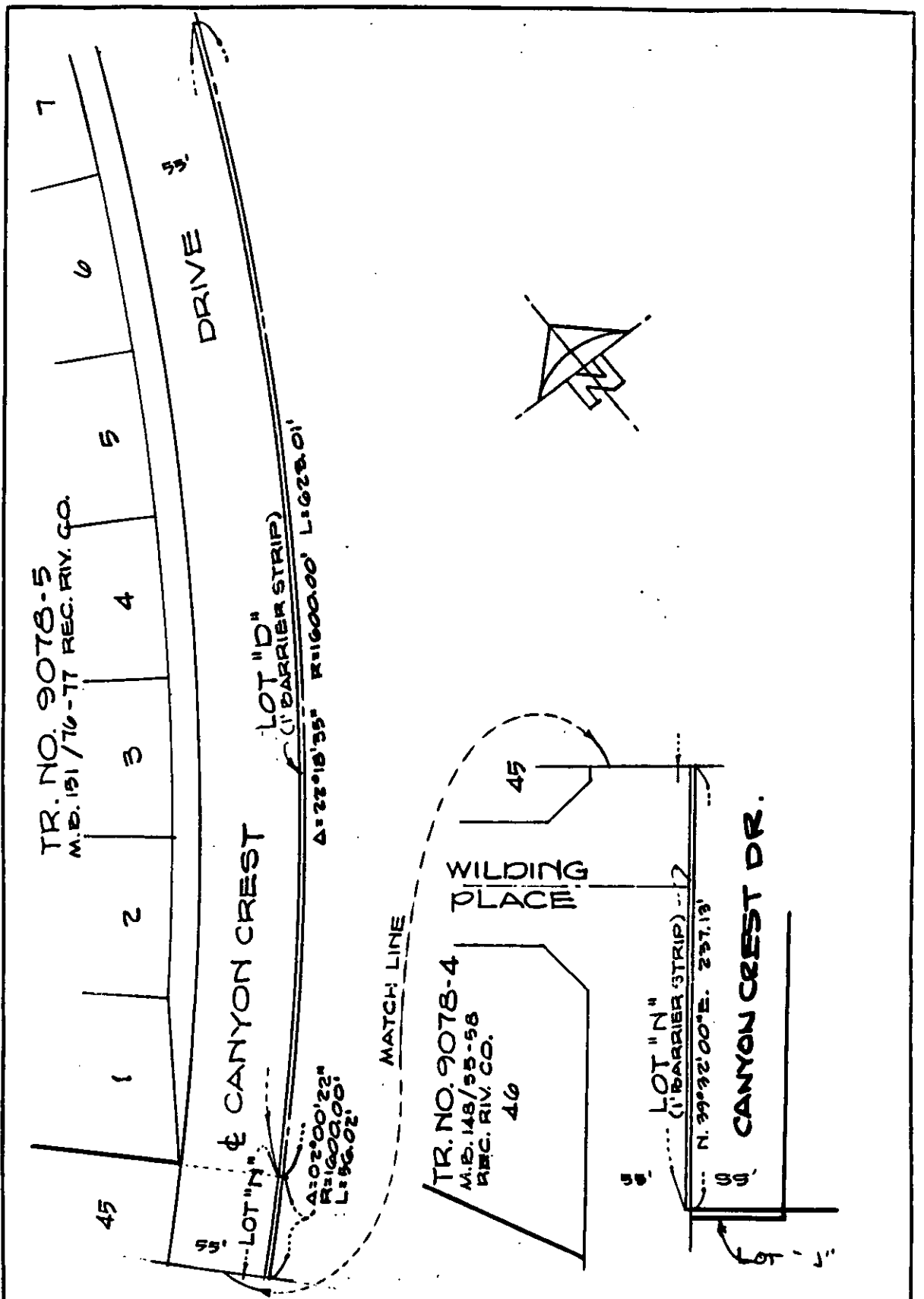

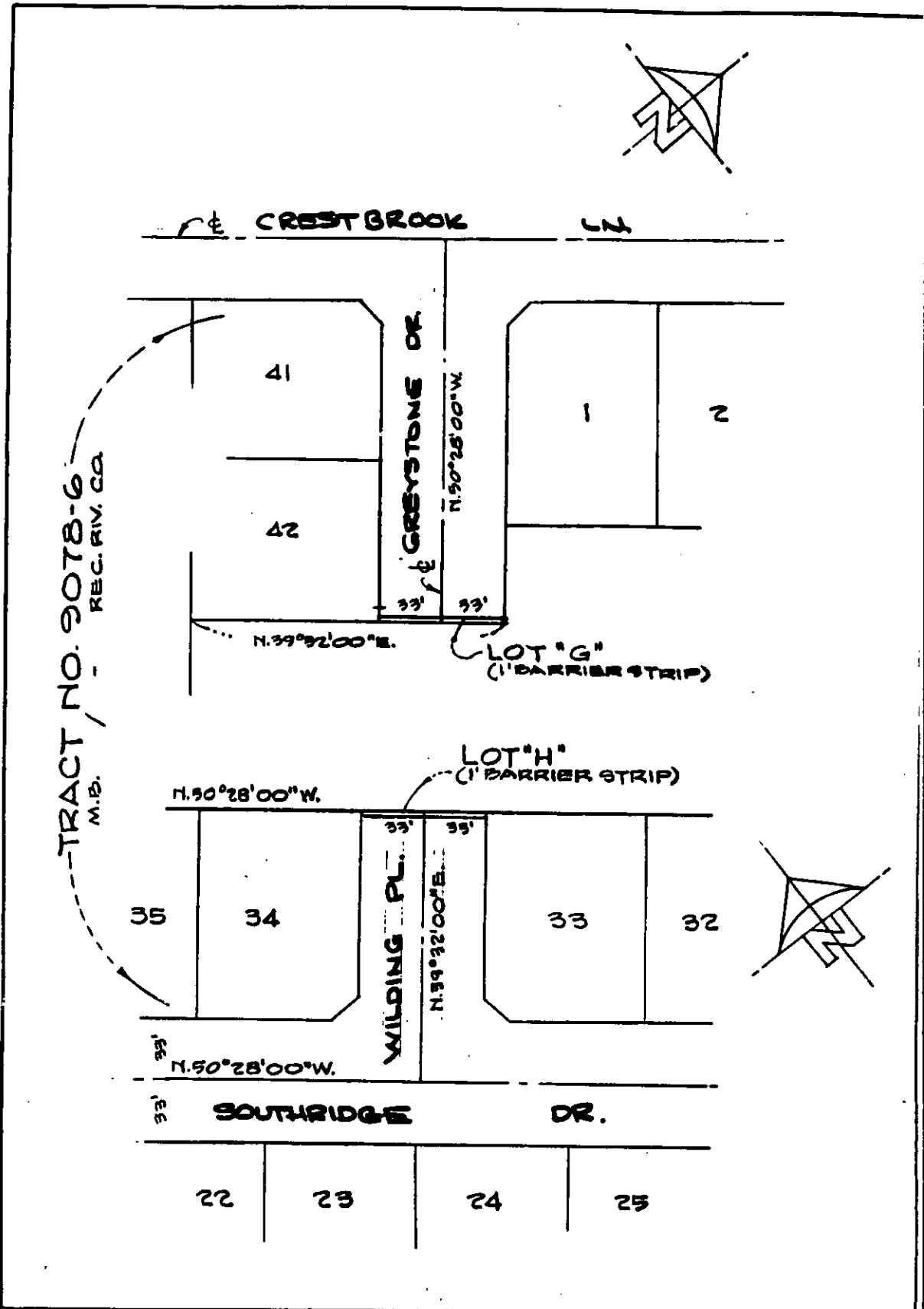
