TEMPORARY CONSTRUCTION
EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, DOUGLAS M. GREENE and SHARENE L. GREENE, husband and wife as joint tenants as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, a temporary easement and right-of-way for the purpose of reconstructing the grantor's driveway to match the planned Central Avenue improvements, together with all necessary appurtenances, in, under, upon, over and along that certain real property in the City of Riverside, County of Riverside, State of California, described as follows:

The North 5.00 feet, of the South 12.00 feet of Lot 4 of Hibiscus Tract, as shown by map on file in Book 24 of Maps at Page 64 thereof, Records of said Riverside County.

AREA - 340 square feet.

Said temporary construction easement is to be used for all purposes proper and convenient in the reconstruction of the grantor's driveway to match the said planned improvements, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

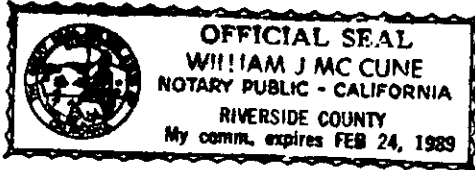
