RESOLUTION NO. 15767

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 15746; RESERVING PERMANENT EASEMENTS AND RIGHTS OF WAY FOR ELECTRICAL ENERGY DISTRIBUTION AND GAS LINE FACILITIES AND DETERMINING THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE RESERVATION OF SUCH EASEMENTS; AND MAKING ITS ORDER VACATING EASTWOOD COURT AND OMAHA COURT ON THE WEST SIDE OF ATLANTA STREET, NORTHERLY OF SPRUCE STREET.

WHEREAS on May 21, 1985, the City Council of the City of Riverside adopted Resolution no. 15746 declaring its intention to order the vacation of Eastwood Court and Omaha Court situated on the west side of Atlanta Street, northerly of Spruce Street, and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Public Streets, Highways, and Service Easements Vacation Law, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Public Streets, Highways, and Service Easements Vacation Law; and

WHEREAS on the day fixed for the hearing the City Council heard and found and hereby finds from all of the evidence submitted that the streets ordered vacated are unnecessary for present or prospective public use;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that Eastwood Court and Omaha Court in the City of Riverside, County of Riverside, State of California, described as follows:

Lot "C" (Eastwood Court) and Lot "D" (Omaha Court) of Parcel Map No. 14669, as shown by map on file in Book 79, pages 38 and 39 of Parcel Maps, Records



be and the same are hereby vacated.

BE IT FURTHER RESOLVED that the City Council does  
hereby determine that the public convenience and necessity  
require the reservation of permanent easements and rights of  
way for gas line and electrical energy distribution facilities,  
and reserving the right to construct, maintain, operate,  
replace, remove, renew and enlarge lines of pipe, conduits,  
cables, wires, poles and other convenient structures, equipment  
and fixtures for the operation of gas lines and for the  
transportation or distribution of electric energy; including  
access and the right to keep the property free from inflammable  
materials and wood growth that would interfere with the use  
of said permanent easements and rights of way.

BE IT FURTHER RESOLVED that the vacation shall occur  
only after the applicable conditions contained in the Planning  
Department's report to the legislative body dated January 4,  
1985, and on file with the City Clerk have been satisfied; and  
the City Clerk is hereby directed not to record this resolution  
of vacation until the applicable conditions have been satisfied.

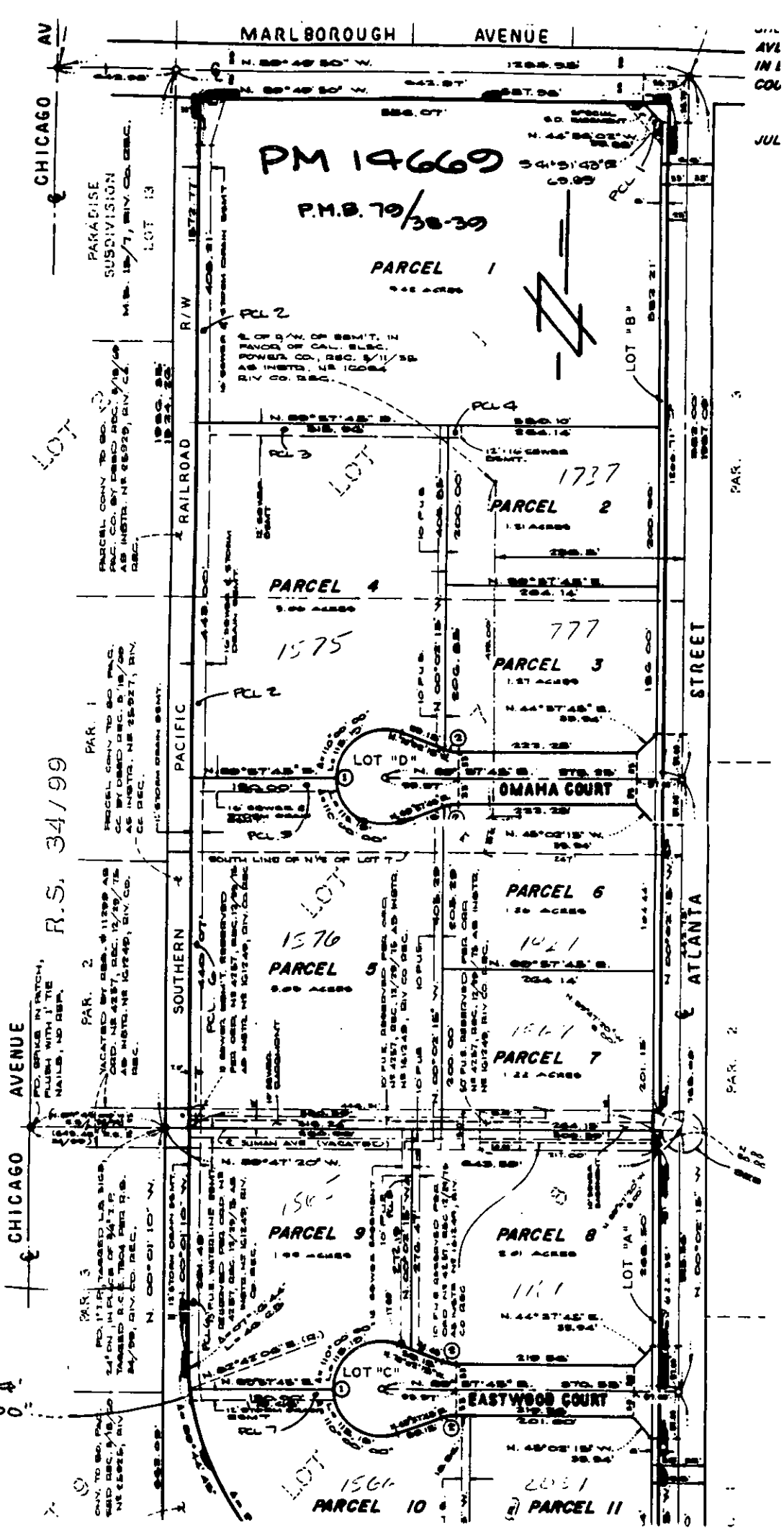
