WAIVER OF VEHICULAR ACCESS

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, GEORGE HENRY LOCY and TEXAS JANE LOCY, husband and wife as joint tenants, hereby forever waive and relinquish all rights of vehicular ingress and egress from Arlington Avenue a public street in the City of Riverside, California, to the below described property, and this waiver and relinquishment shall be binding upon the undersigned and upon the heirs, successors and assigns of the undersigned, all of whom shall not permit vehicular ingress or egress from said street to said property, which property is described as follows:

That portion of Lot 6 in Block 80 of Arlington Heights, as shown by map on file in Book 11, Pages 20 and 21 of Maps, records of San Bernardino County, California, described as follows:

COMMENCING at a point in the centerline of Kronen Court (formerly Arlington Avenue), distant thereon North 89° 30' 10" East, 792.25 feet from the intersection of centerline of Victoria Avenue with the centerline of Arlington Avenue as shown on said map;

THENCE South 0° 29' 50" East, a distance of 40 feet to the northeasterly corner of that certain parcel of land conveyed to Hubert H. Kronen, et ux., by deed recorded May 26, 1961, as Instrument No. 44989 of Official Records of said Riverside County, and the POINT OF BEGINNING of the parcel of land being described;

THENCE continuing South 0° 29' 50" East, along the east line of said parcel, 114.00 feet to the south line of said parcel;

THENCE South 89° 30' 10" West, along said south line, a distance of 60.87 feet to a point in the northeasterly line of Arlington Avenue as widened by Judgement of Condemnation, a certified copy of the Final Order of Condemnation recorded November 2, 1966, as Instrument No. 107675 of Official Records of said Riverside County;

THENCE North 53° 59' 00" West, along said northeasterly line, a distance of 57.40 feet to the west line of said parcel;

THENCE North 0° 29' 50" West, along said west line, a distance of 79.85 feet to the north line of said parcel;

THENCE North 89° 30' 10" East, along said north line, a distance of 107.00 feet to said POINT OF BEGINNING.

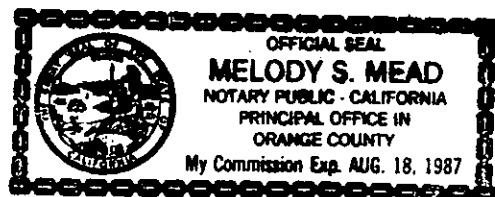

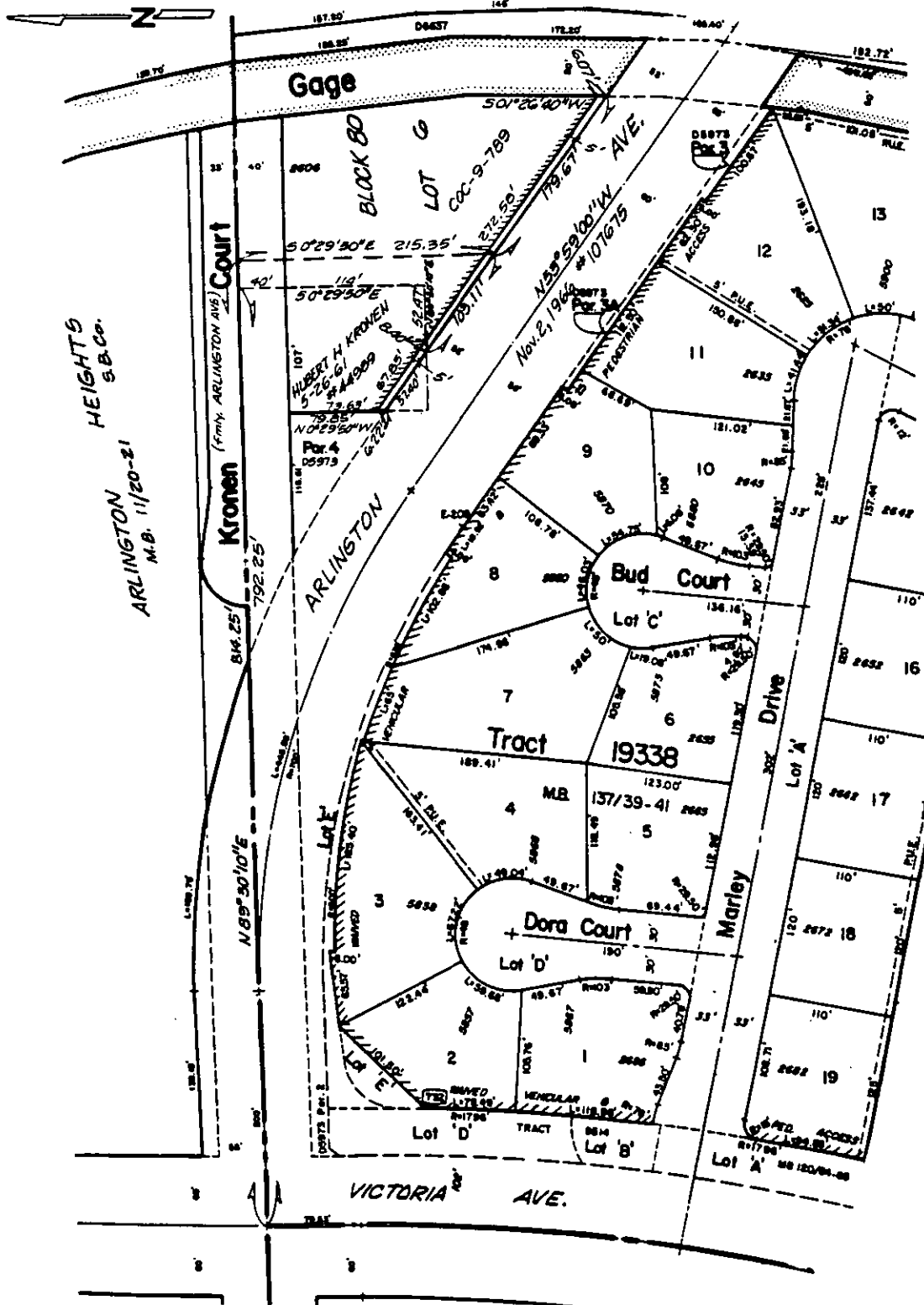
