A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF ADAMS STREET FROM THE FREEWAY TO LINCOLN AVENUE TO ADAMS STREET/AUTO CENTER DRIVE.

FREE RECORDING-

Exempt Pursuant to Government Code Section 66103

BE IT RESOLVED by the City Council of the City of Riverside, California, that the name of that portion of Adams Street from the Freeway to Lincoln Avenue, described as follows:

All that portion of Adams Street as shown by map of the Riverside Land and Irrigating Company on file in Book 1, Page 70 of Maps, records of San Bernardino County, California, together with all that portion of Adams Street as shown by map of Arlington Heights on file in Book 11, Pages 20 and 21 of Maps, records of said San Bernardino County, lying northwesterly of the southwesterly prolongation of the southeasterly line of Block 41 of said map of Arlington Heights, and lying southeasterly of the following described line:

Commencing at the most easterly corner of Lot 16 in Block 23 of said map of the Riverside Land and Irrigating Company;

Thence North 33° 37' 54" West, along the northeasterly line of said Lot 16 in block 23, a distance of 440.65 feet to the southeasterly line of that certain parcel of land as shown by map of Relinquishment on file in Book 2, Page 141 of State Highway Maps, records of Riverside County, California, and the true Point of Beginning of the line to be described;

Thence North 76° 44' 10" East, a distance of 85.33 feet to the southwesterly line of Lot 13 in Block 22 of said map of the Riverside Land and Irrigating Company, and the end of this line description;

be changed to ADAMS STREET/AUTO CENTER DRIVE.

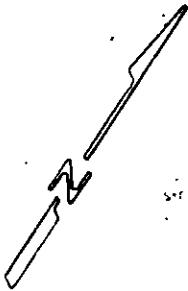
