FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, GEORGE R. SMITH and FLORENCE SMITH, Co-Trustees of the Smith Family Trust under Declaration of Trust dated February 18, 1982, as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of electrical energy distribution facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

A portion of Parcel 2 of parcel map on file in Book 7 of Parcel Maps, at Page 23 thereof, records of Riverside County, California, together with a portion of Parcel 1 of parcel map on file in Book 80 of Parcel Maps, at Pages 6 and 7 thereof, records of Riverside County, California, together with portions of Parcel 1 and Parcel 2 of parcel map on file in Book 7 of Parcel Maps, at Page 22 thereof, records of Riverside County, California, being more particularly described as follows:

BEGINNING at the southeasterly corner of Parcel 2 of parcel map on file in Book 7 of Parcel Maps, at Page 23 thereof, records of Riverside County, California;

THENCE North 00° 20' 40" East, along the east line of last mentioned Parcel 2 and the northerly prolongation thereof, a distance of 471.84 feet to a point on the south line of Parcel 2 of parcel map on file in Book 7 of Parcel Maps, at Page 22 thereof, records of Riverside County, California;

THENCE South 89° 39' 20" East, along last mentioned south line, a distance of 10.00 feet;

THENCE North 00° 20' 40" East, a distance of 10.00 feet;

THENCE North 89° 39' 20" West, parallel with last mentioned south line, a distance of 25.00 feet;

THENCE South 00° 20' 40" West, a distance of 443.49 feet;



