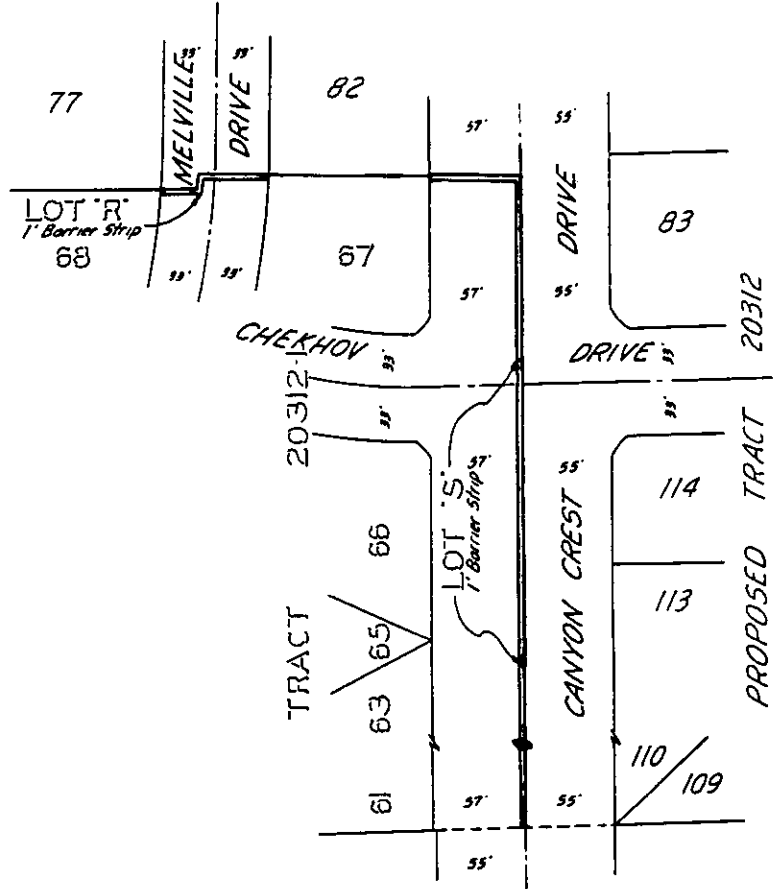

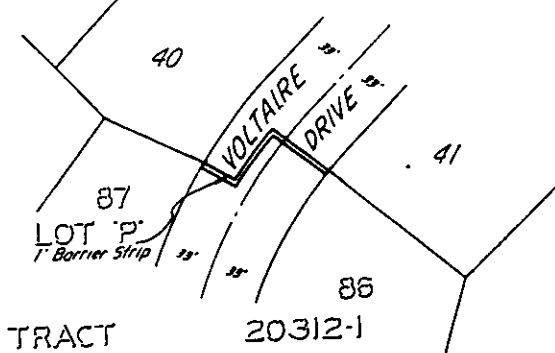

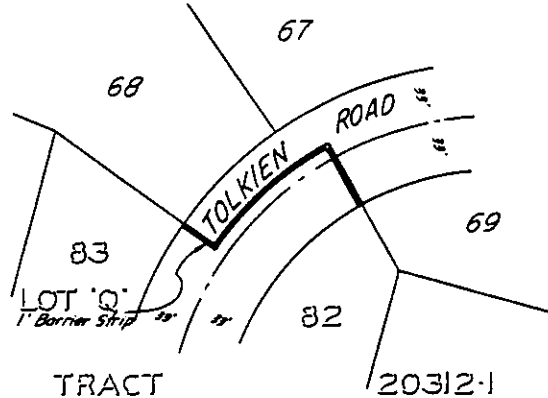
PROPOSED TRACT 20312
