

## EASEMENT

The northerly 270 feet of the easterly 5.00 feet of the westerly 13.00 feet of Iowa Avenue Extension (vacated) of Olive Heights, as shown by map on file in Book 5, Page 163 of Maps, records of said Riverside County; said northerly 270 feet lying 270 feet northerly from the westerly prolongation of the centerline of Violet Street (vacated) as shown by said map of Olive Heights.
