A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACTS NOS. 19958-1, 19958-2 AND 19958-3 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 21638-1) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF COLE AVENUE AND BERGAMONT DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Cole Avenue and Bergamont Drive:

That portion of Lot "G" of Tract 19958-2 as shown by map on file in Book 170 of Maps at Pages 72 through 76 thereof, records of Riverside, California, lying adjacent to the easterly line of Tract 21638-1 as shown by map on file in Book 170 of Maps at Pages 85 through 89 thereof, records of Riverside County, California, and being bounded southerly by the easterly prolongation of the southerly line of Lot "H" of said Tract 21638-1.

That portion of Lot "M" of Tract 19958-1 as shown by map on file in Book 170 of Maps at Pages 67 through 71 thereof, records of Riverside County, California, lying adjacent to the easterly line of Tract 21638-1 as shown by map on file in Book 170 of Maps at Pages 85 through 89 thereof, records of Riverside County, California, and bounded northerly by the northeasterly prolongation of the northerly line of Lot "H" of said Tract 21638-1.

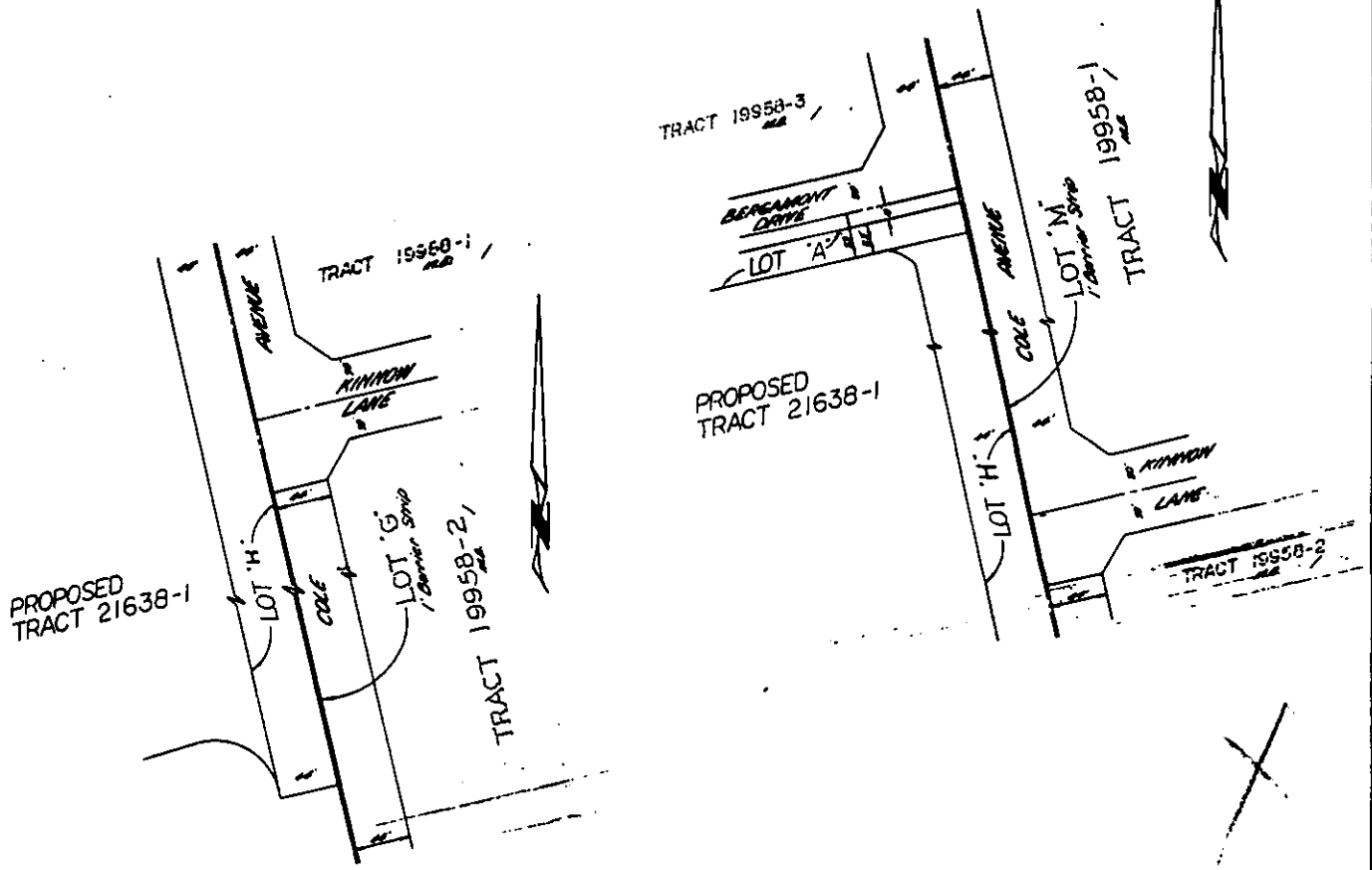
