E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, SUMMIT POINTE ASSOCIATES, a California general partnership, as Grantor, grants to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of electrical energy distribution facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

Parcel 1

Being a portion of the East half of Section 7, Township 3 South, Range 4 West of the San Bernardino Meridian, more particularly described as follows:

COMMENCING at the most southerly corner of Tract 9078-6 as shown by map on file in Map Book 156, Pages 58 through 60, records of Riverside County, California;

THENCE North 39° 52' 00" East along the easterly line of said Tract 9.00 feet to the point of intersection with the easterly line of Alessandro Blvd., said easterly line being 64.00 feet easterly and parallel with the centerline of Alessandro Boulevard;

THENCE southeasterly along said easterly line being a curve concave southwesterly, having a radius of 3774.70 feet, through a central angle of 5° 05' 32", an arc length of 335.48 feet to the point of beginning, said beginning point having a radial bearing which bears North 44° 58' 42" East;

THENCE North 41° 20' 12" East 30.70 feet to a point on a non-tangent curve concave southwesterly, having a radius of 3400.00 feet, having a radial bearing which bears North 40° 52' 01" East;

THENCE southeasterly along said easterly line being a curve concave southwesterly, having a radius of 3774.70 feet, through a central angle of $20^{\circ} 20' 43''$, an arc length of 1340.37 feet to the point of beginning, said beginning point having a radial bearing which bears North $60^{\circ} 13' 53''$ East;

THENCE southeasterly along said easterly line being a curve concave southwesterly, having a radius of 3774.70 feet, through a central angle of $12^{\circ} 36' 59''$, an arc length of 831.18 feet to the point of beginning, said beginning point having a radial bearing which bears North $52^{\circ} 30' 09''$ East;

THENCE northerly along said easterly line through a central angle of 0° 04' 35", an arc length of 5.03 feet to the POINT OF BEGINNING.

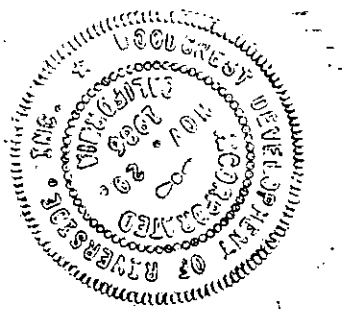

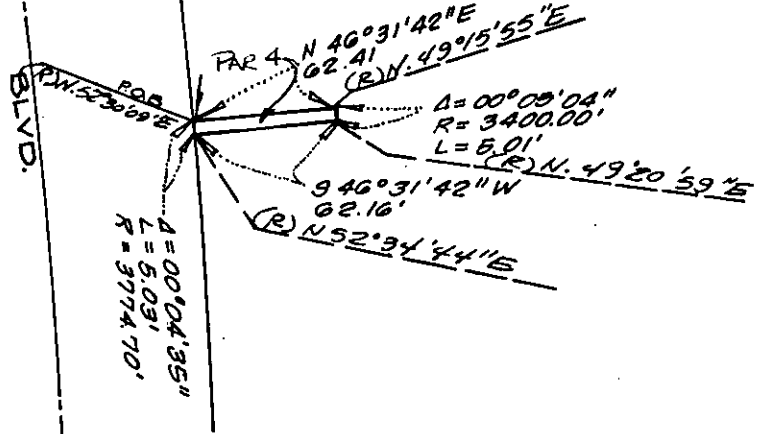
MOST S'LY CORNER
