A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING FOR PUBLIC STREET PURPOSES TO BE KNOWN AS A PORTION OF TWO TREES ROAD LOT F OFFERED FOR DEDICATION BY THE TRACT MAP FOR BELVEDERE HEIGHTS.

WHEREAS in connection with tract map for Belvedere Heights, as shown by map on file in Book 22, Page 31 of Maps, records of Riverside County, California, Lot F thereof was offered for dedication for public use for street purposes; and

WHEREAS the City Council of the City of Riverside in connection with the approval of Parcel Map 21822 wishes to accept said Lot F for public street purposes to be known as a portion of Two Trees Road;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That the hereinafter described property irrevocably offered for dedication for public street purposes by Tract Map for Belvedere Heights on file in Book 22, Page 31 of Maps, Records of Riverside County, California, is hereby accepted by the City of Riverside for public street purposes to become and be known as a portion of Two Trees Road together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street. The aforementioned property accepted for public street purposes is situated within the City of Riverside, County of Riverside, State of California, and is described as follows:

Lot F of Belvedere Heights, as shown by map on file in Book 22, Page 31 of Maps, records of Riverside County, California.

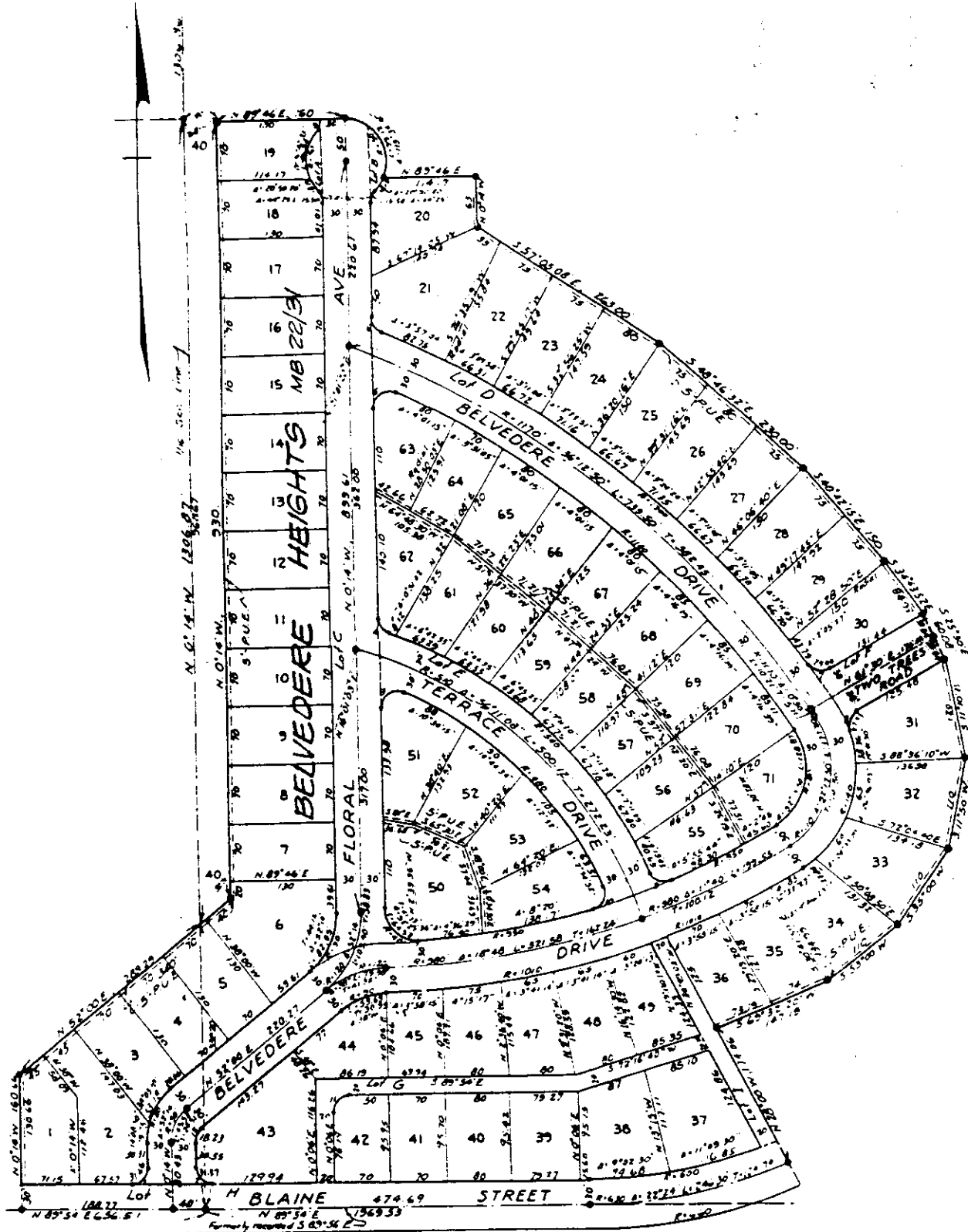
