GRANT DEED

YEAGER BROTHERS, a partnership, Grantor, FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a municipal corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

Those portions of Lot 5 of the Wilbur Tract, as shown by map on file in Book 6, Page 4 of Maps, records of San Bernardino County, California, described as follows:

Parcel 1

COMMENCING at the intersection of the south line of said Lot 5 with the southeasterly line of the Atchinson, Topeka and Santa Fe Railroad right-of-way;

THENCE North 45° 15' 49" East, along said southeasterly line, a distance of 46.87 feet to the northerly line of Spruce Street (formerly Indianapolis Avenue), and the POINT OF BEGINNING of the parcel of land being described;

THENCE South 89° 58' 38" East, along said northerly line, a distance of 375.38 feet to the westerly line of that certain parcel of land conveyed to Riverside County Flood Control and Water Conservation District by Grant Deed recorded February 8, 1979, as Instrument No. 27265 of Official Records of said Riverside County;

THENCE North 07° 37' 51" East, along said westerly line, a distance of 11.10 feet to a line parallel with and distant 44.00 feet northerly, as measured at right angles, from said south line of Lot 5;

THENCE North 89° 58' 38" West, along said parallel line, a distance of 365.75 feet to said southeasterly line of the Atchison, Topeka and Santa Fe Railroad right-of-way;

THENCE South 45° 15' 49" West, along said southeasterly line, a distance of 15.62 feet to the POINT OF BEGINNING.

THENCE South 89° 58' 38" East, along said northerly line, a distance of 114.74 feet to the westerly boundary of that certain parcel of land conveyed to G. S. Medsger by document recorded October 24, 1894, in Book 13, Page 213 et seq., of Deeds, records of said Riverside County;

THENCE North 06° 00' 49" East, along said westerly boundary, a distance of 11.06 feet to a line parallel with and distant 44.00 feet northerly, as measured at right angles, from said south line of Lot 5;

THENCE North 89° 58' 38" West, along said parallel line, a distance of 114.43 feet to said easterly line of said parcel so conveyed to Riverside County Flood Control and Water Conservation District;

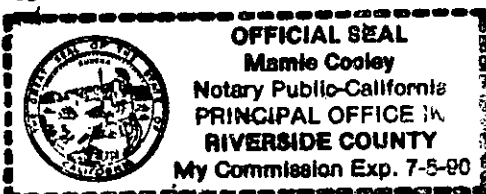

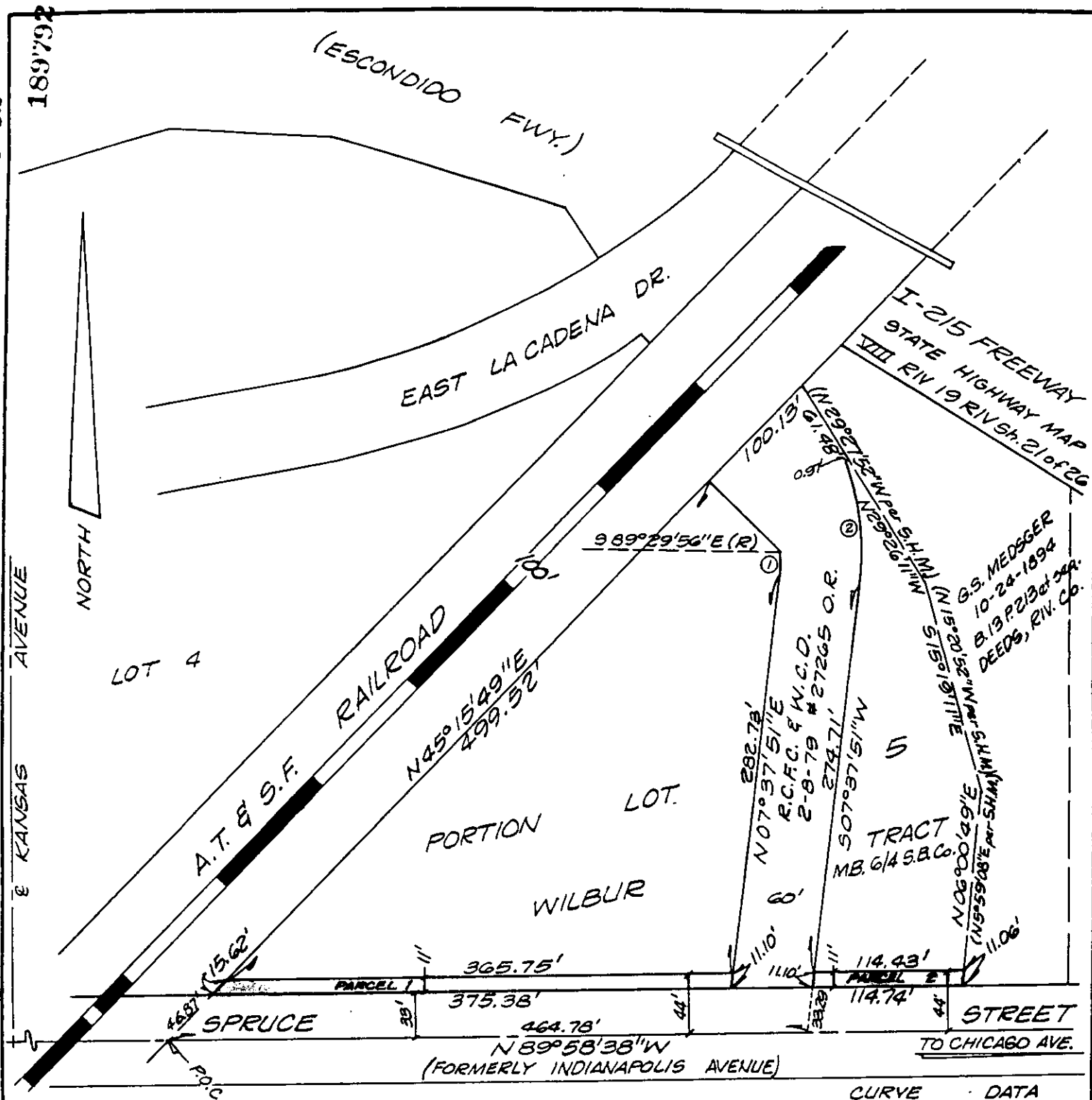
