THE METROPOLITAN WATER DISTRICT OF SOUTHERN CALIFORNIA,
a public corporation, hereby grants to

CITY OF RIVERSIDE,
a municipal corporation,

a permanent easement to construct, use, maintain, alter, add to,
enlarge, repair, replace, inspect, and/or remove at any time and
from time to time a 12kV underground electrical transmission
line with every appendage necessary be to installed at any time
in connection therewith, within the real property, in the City
of Riverside, County of Riverside, State of California,
described as follows:

A parcel of land in Lot 1, Block 5, Alessandro
Tract, as shown on map recorded in Book 6, page 13, of
Official Records in the Office of the County Recorder of
the County of San Bernardino, California, being in the
southeast quarter of Section 8, Township 3 South, Range 4
West, San Bernardino Meridian, in the City of Riverside, County
of Riverside, State of California, said parcel of land being

Beginning at the northwest corner of that certain permanent easement conveyed to the Eastern Municipal Water District under designation Parcel C, in permanent easement deed recorded September 1, 1981, as Instrument No. 166338, of Official Records, in the Office of the County Recorder of the County of Riverside, California; thence westerly along the westerly prolongation of the north line of said certain permanent easement to a line that is parallel with and distant 12 feet westerly, measured at right angles, from the west line of said certain permanent easement; thence southerly along said parallel line 125 feet to a line that is parallel with and distant 12 feet southerly, measured at right angles, from the southerly line, and its westerly prolongation, of said certain permanent easement; thence easterly along said last-mentioned parallel line 100 feet; thence northerly at right angles to said last-mentioned course, 12 feet to said southerly line; thence westerly along said southerly line 88 feet to the southwest corner thereof; thence northerly along said westerly line 113 feet to the northwest corner thereof and the point of beginning.

Containing 0.06 acre, more or less.

This easement is granted subject to the following terms:

1. It is subject to Grantor's paramount right to use the above-described property for the purposes for which it was acquired.
2. Grantee shall submit in advance all plans for installation, construction, or reconstruction of Grantee's facilities to Grantor for review and written approval.
3. Grantee shall not change the existing grade or otherwise modify the topography of property affected by this easement without prior written consent of Grantor.
4. Grantee assumes all risk of loss to itself, which in any manner may arise out of the use of the easement. Further, Grantee shall indemnify and defend Grantor, and its directors, officers, and employees against any liability and expenses, including the reasonable expense of legal representation whether by special counsel or by Grantor's staff attorneys, resulting from injury to or death of any person, or damage to any property, including property of Grantor, or damage to any other interest

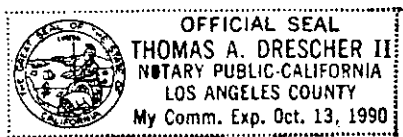

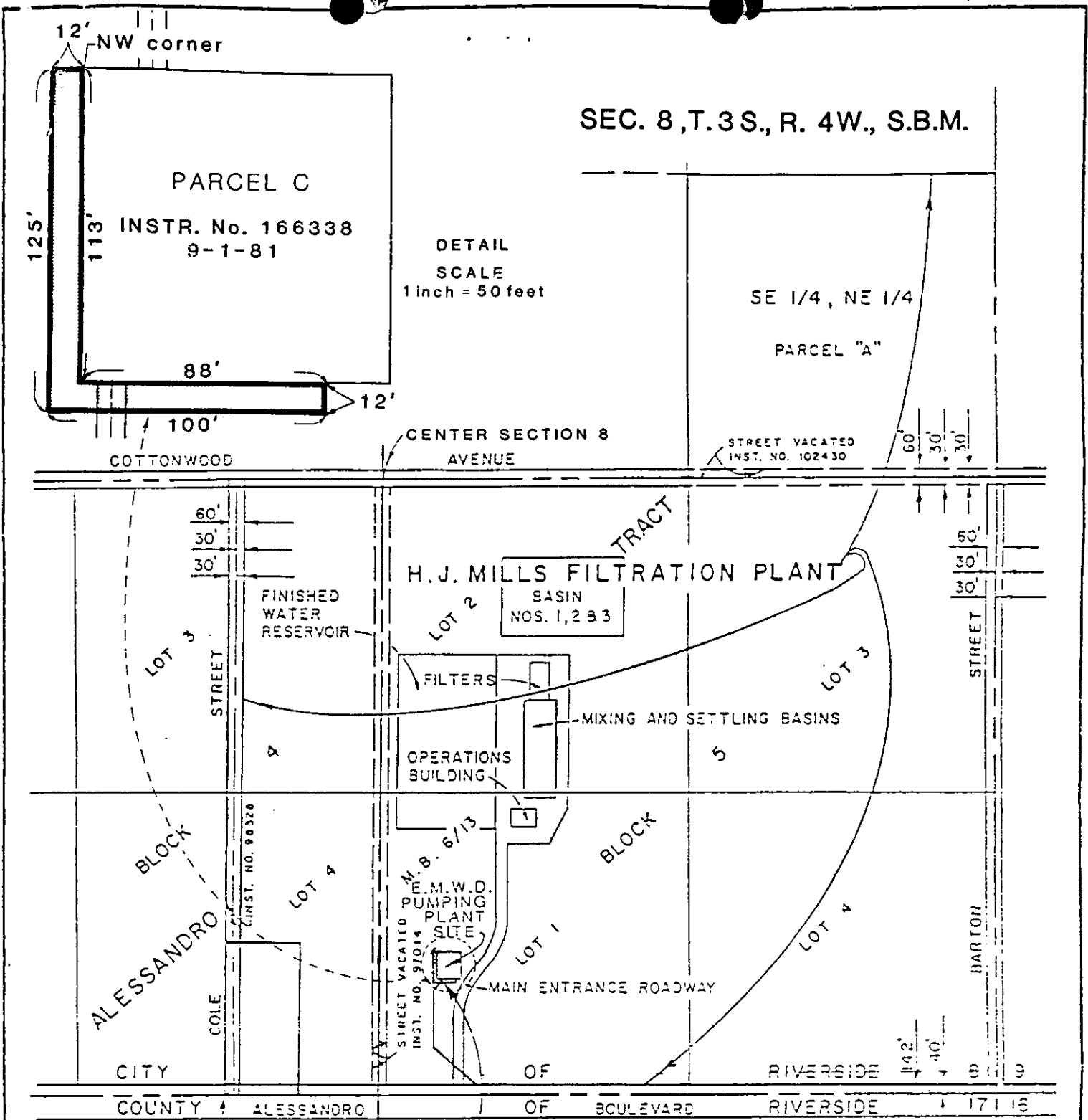
