SPIEGEL, Co-Trustees of the SPIEGEL LIVING TRUST created on September 28, 1983, as to an undivided two-thirds interest, as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of traffic signal and related electrical facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

THENCE South 00° 07' 00" West, along the centerline of said Chicago Avenue, a distance of 514.50 feet;

THENCE North 89° 53' 00" West, a distance of 55.00 feet to the westerly line of that certain parcel of land conveyed to the City of Riverside by Grant Deed recorded January 5, 1962, as Instrument No. 1447 of Official Records of said Riverside County, and the POINT OF BEGINNING of the parcel of land being described;

THENCE North 00° 07' 00" East, along said westerly line, a distance of 4.00 feet;

THENCE North 89° 53' 00" West, a distance of 30.00 feet to a line parallel with and distant 85.00 feet westerly, as measured at right angles, from said centerline of Chicago Avenue;

THENCE South 00° 07' 00" West, along said parallel line, a distance of 33.00 feet;

THENCE South 89° 53' 00" East, a distance of 30.00 feet to said westerly line;

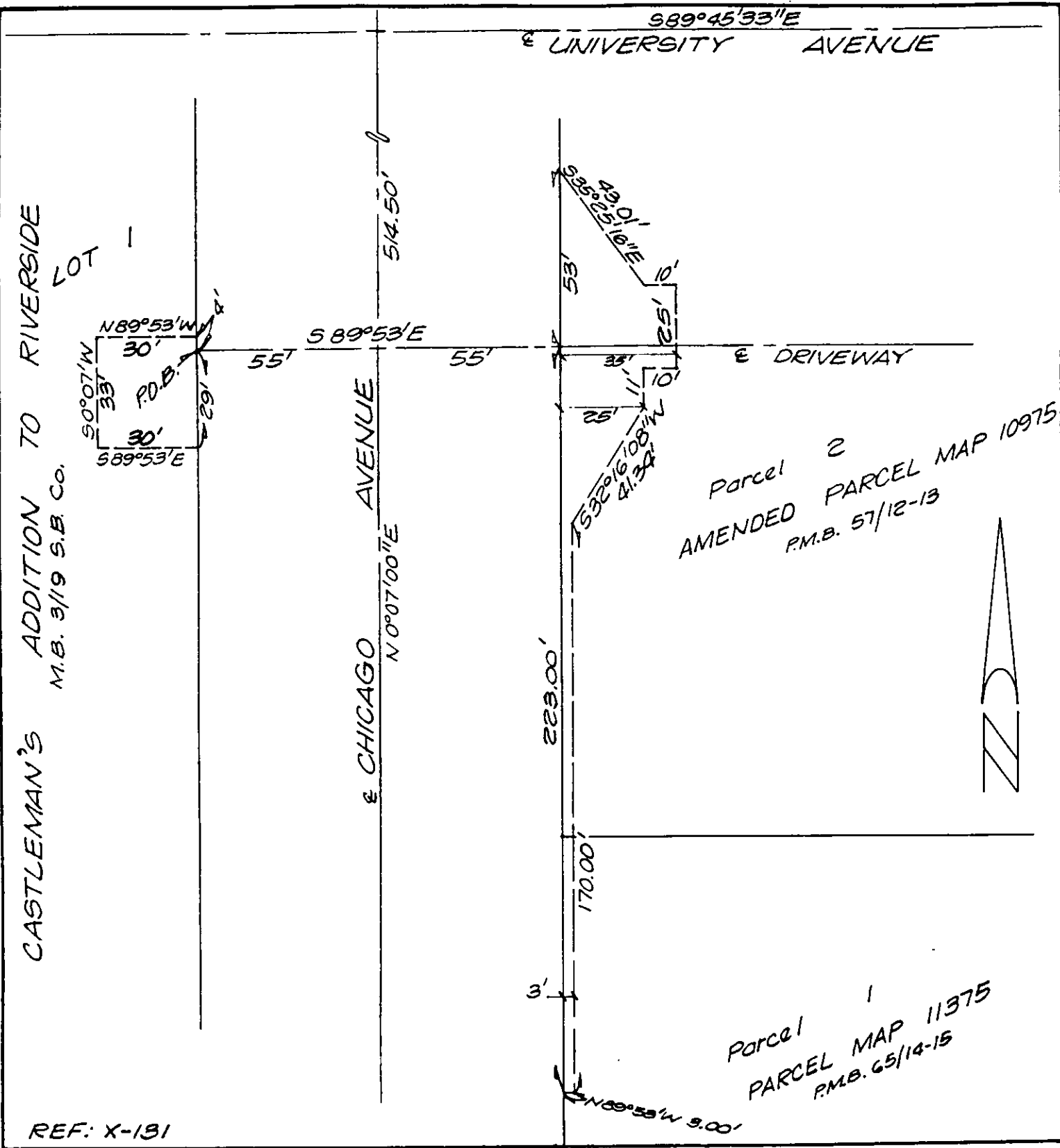
