BEGINNING at the southwest corner of said Lot 20;

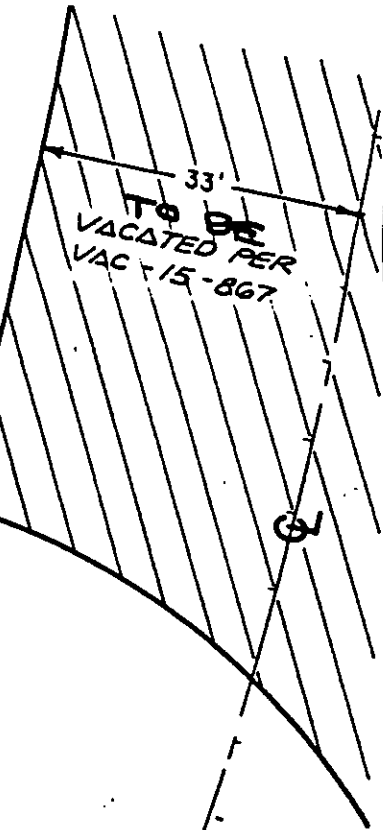
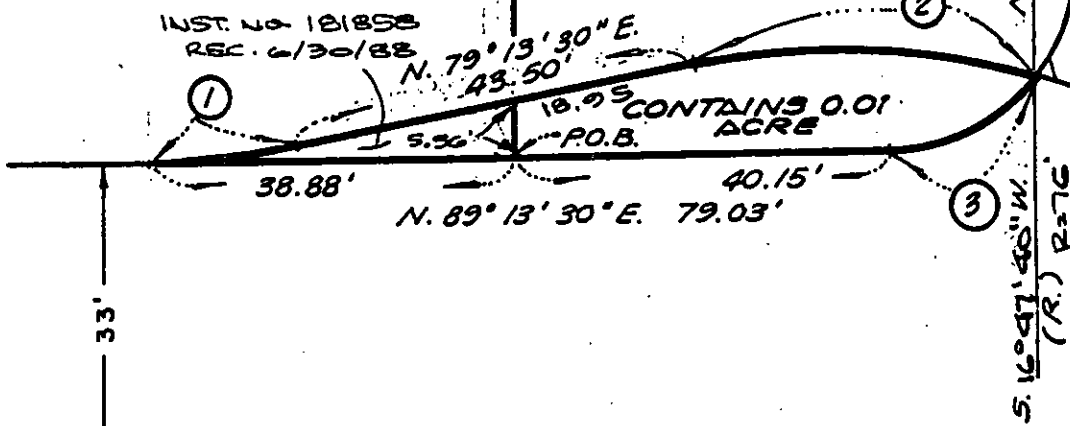
