E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,  
VENTURA COUNTY EMPLOYEES' RETIREMENT ASSOCIATION,

as Grantor, grants to the CITY OF RIVERSIDE, a Municipal Corporation of  
the State of California, as Grantee, its successors and assigns, a  
perpetual easement and right of way for the construction, reconstruction,  
maintenance, operation, inspection, repair, replacement, relocation,  
renewal and removal of electrical energy distribution facilities,

together with all necessary appurtenances, in, under, upon, over and along  
that certain real property situated in the City of Riverside, County of  
Riverside, State of California, described as follows:

A strip of land 15.00 feet in width lying within that portion of the west  
half of Lot 25 in Section 19, Township 2 South, Range 4 West, of the Lands  
of the East Riverside Land Co., as shown by map on file in Book 6, Page 44  
of Maps, records of San Bernardino County, California, described as  
follows:

BEGINNING at the northwest corner of Parcel 3 of Parcel Map No. 17,402, as  
shown by map on file in Book 119, Pages 50 and 51 of Parcel Maps, records  
of Riverside County, California;

THENCE South 0° 11' 05" West, along the westerly line of said Parcel 3 and  
along the westerly line of Parcel 2 of said Parcel Map, a distance of  
292.78 feet to the northerly line of that certain easement conveyed to the  
City of Riverside by document recorded June 19, 1981, as Instrument No.  
115042 of Official Records of said Riverside County;

THENCE North 89° 48' 40" West, along said northerly line, a distance of  
15.00 feet;

THENCE North 0° 11' 05" East, a distance of 292.77 feet to the north line  
of said Lot 25;

THENCE South 89° 50' 50" East, along said north line a distance of 15.00  
feet to the POINT OF BEGINNING;

EXCEPTING THEREFROM that portion lying within the northerly 61.00 feet of  
said west half of Lot 25 which was conveyed to CROW-LANE-RIVERSIDE # 2  
LIMITED PARTNERSHIP, by deed recorded May 24, 1989, as Instrument No.  
169272 of Official Records of said Riverside County.

TOGETHER WITH the right to clear and keep clear said easement and right of way from any structures or trees, to enter upon and to pass and repass over and along said real property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees, whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said electrical energy distribution facilities.

Provided, however, that the Grantor reserves the right to use and enjoy the land over which said easement and right of way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.

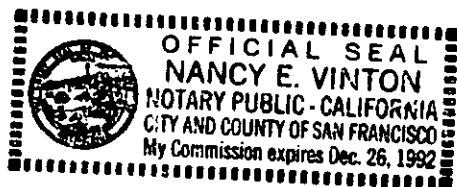

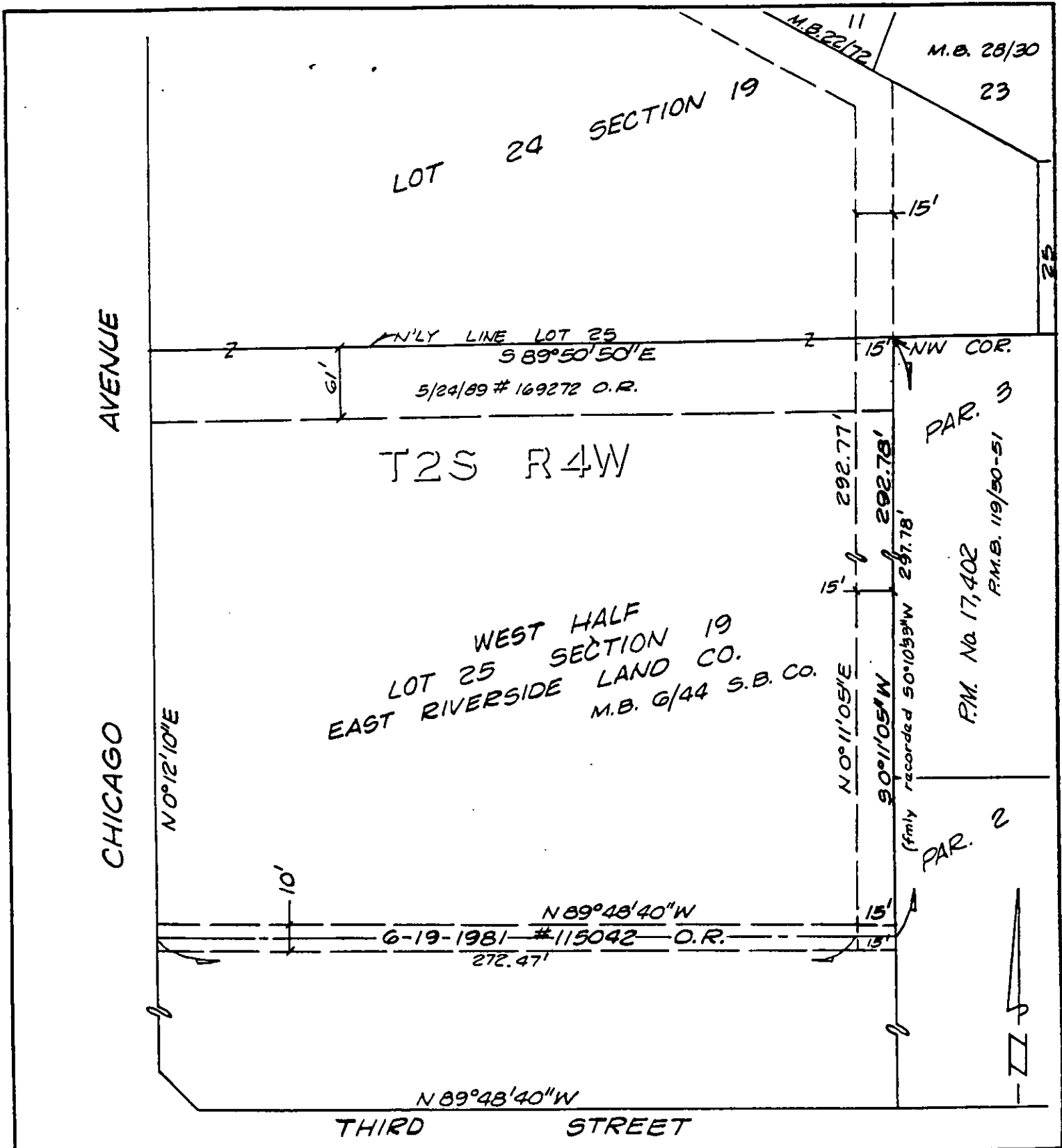
