
Lot "G" of Tract 21638-2 as shown by map on file in Book 170 of Maps at Pages 90 through 93 thereof, records of Riverside County, California.

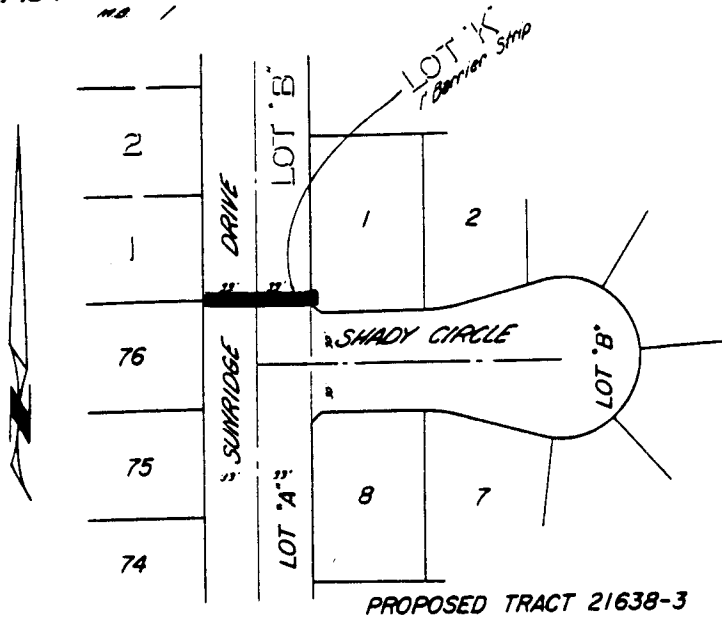

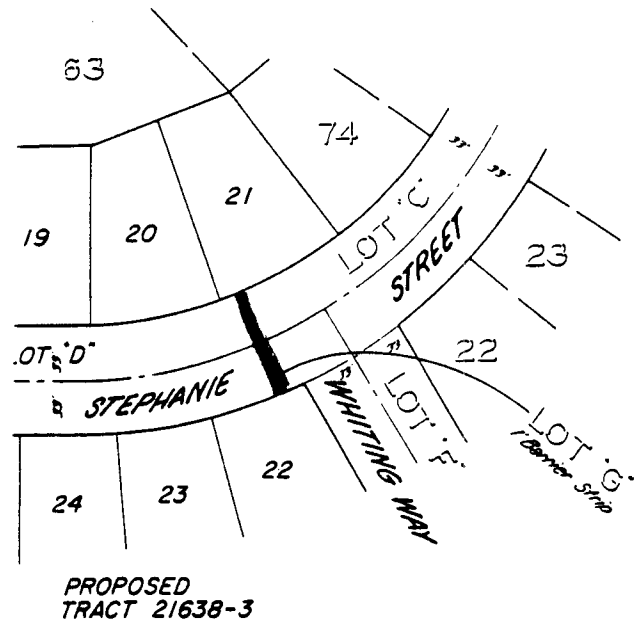
