GRANT DEED

MICHAEL L. LAUZON, a single man, Grantor, FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a municipal corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lots 7 and 8 in Block "A" of Franklin Square, as shown by map on file in Book 6, Page 31 of Maps, records of San Bernardino County, California, and that portion of the easterly one-half of that certain alley (vacated) in said Block "A" adjoining the west line of said Lot 7, described as follows:

BEGINNING at the northeast corner of said Lot 8;

THENCE South along the east line of said Lot 8, a distance of 8.00 feet to a line parallel with and distant 33.00 feet southerly, as measured at right angles, from the centerline of Ninth Street;

THENCE West along said parallel line, a distance of 109.5 feet to the west line of said easterly one-half of said alley (vacated);

THENCE North along said west line, a distance of 8.00 feet to the westerly prolongation of the north line of said Lot 7;

THENCE East along said prolongation and along the north line of said Lots 7 and 8, a distance of 109.5 feet to the POINT OF BEGINNING.



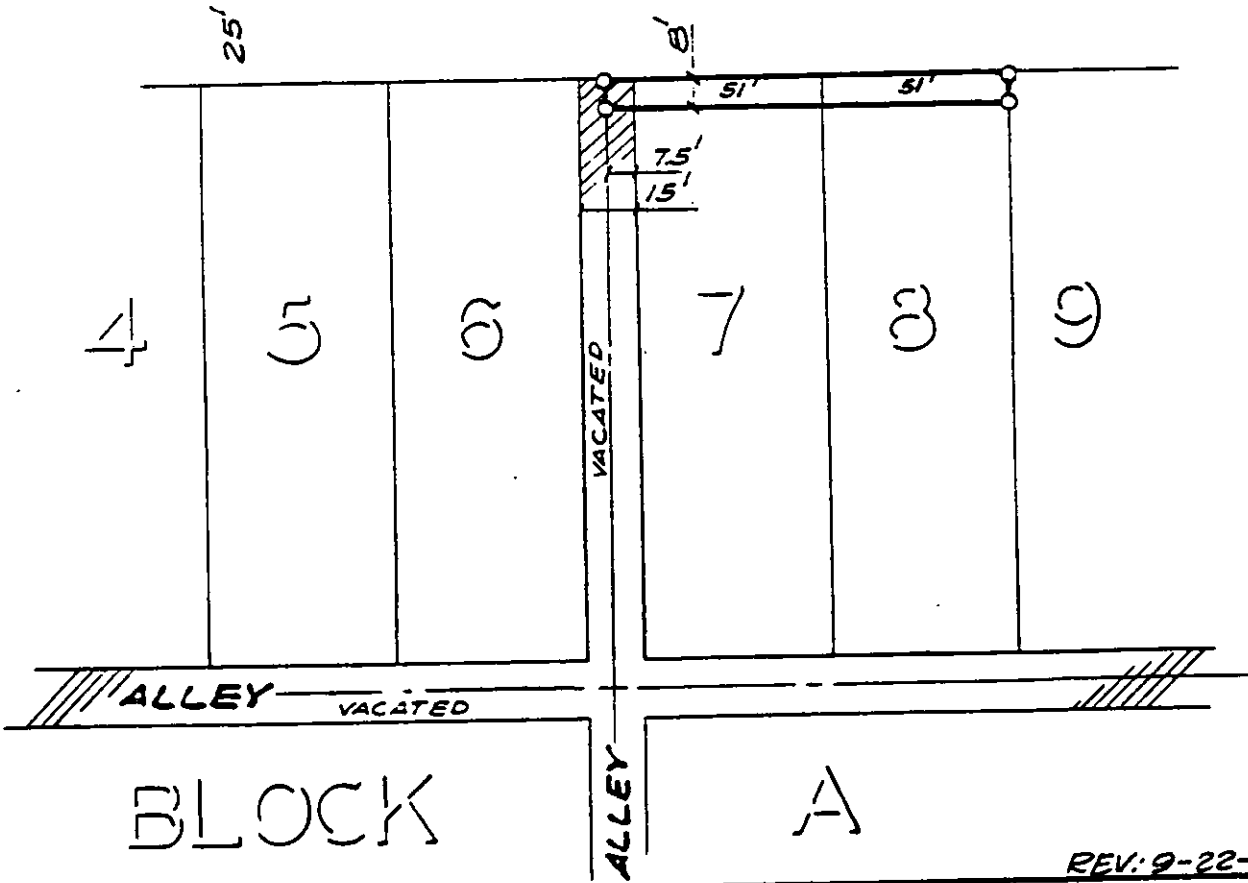
