**GRANT OF EASEMENTS FOR INGRESS AND EGRESS
AND DECLARATION OF COVENANTS**

This indenture is made this 16th day of December, 1989, by and between SIMCHOWITZ-W NO. 1, a California limited partnership ("SW") and CITY OF RIVERSIDE, a Municipal corporation ("City"), to be effective upon the date of its recordation.

WHEREAS, SW is seized in fee simple of that parcel of real property which is described on Exhibit "A" attached hereto and incorporated herein by reference ("Servient Tenement"); and

WHEREAS, City is seized in fee simple of that parcel of real property which is described on Exhibit "B" attached hereto and incorporated herein by reference ("Dominant Tenement"); and

WHEREAS, the Parties hereto wish to create an express easement upon, over, under, and across the Servient Tenement, appurtenant to and for the benefit of the Dominant Tenement, and to declare covenants as herein provided;

NOW, this indenture witnesseth as follows:

1. *Grant of Easement.*

SW does hereby grant to City a perpetual and non-exclusive easement ("Easement") upon, over, under, and across that portion of the Servient Tenement described on Exhibit "C" and as drawn on Exhibit "D", both attached hereto and incorporated herein by reference, for the purpose of ingress and egress to and from the Dominant Tenement whether by automobile, truck, van, bus, carriage, equestrian, pedestrian or any other form of conveyance. City and its officers, directors, guests, employees, vendors, agents, clients, contractors, licensees, invitees and anyone rightfully holding under City shall have a right to enter the Easement, at any time, for the purposes set forth herein.

2. **Obstructions and Interference.**

SW hereby covenants that SW will not install, or permit to be installed, build, or permit to be built, any structure or other obstruction, of any nature whatsoever, which will materially interfere with the use of the Easement.

3. **Easement Appurtenant and Covenants to Run With the Land.**

The Easement set forth herein is and shall be appurtenant. The burdens and the benefit of the covenants set forth herein shall run with and be for the benefit of the land and shall be binding upon, and shall inure to the benefit of, all persons having or acquiring any right, title, or interest therein and their successors and assigns.

4. **Miscellaneous.**

The recitals hereof and each of the Exhibits attached hereto is incorporated herein by reference.

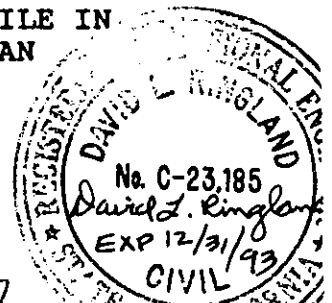

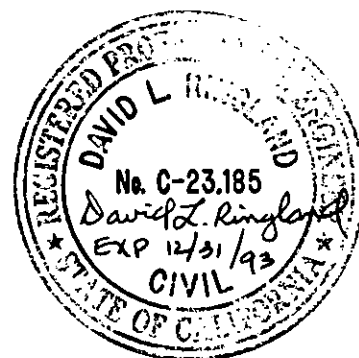
