E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, ROBERT R. ROBINSON and MARGARET R. ROBINSON, husband and wife as joint tenants, as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of electric energy distribution facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 2 in Block 71 of Arlington Heights, as shown by map on file in Book 11, Pages 20 and 21 of Maps, records of San Bernardino County, California, described as follows:

COMMENCING at the most northerly corner of Lot 50 of Heers Subdivision No. 5, as shown by map on file in Book 25, Pages 23 and 24 of Maps, records of Riverside County, California;

THENCE South 34° 00' 00" East, along the northeasterly line of said Lot 50, a distance of 34.00 feet to the POINT OF BEGINNING of the parcel of land being described;

THENCE North 56° 00' 00" East, a distance of 10.00 feet;

THENCE South 34° 00' 00" East, parallel with said northeasterly line, a distance of 1.57 feet;

THENCE North 34° 53' 11" East, a distance of 134.21 feet to the northeasterly line of that certain parcel of land conveyed to Robert R. Robinson, et ux., as Parcel 1 by deed recorded May 2, 1961, as Instrument No. 37172 of Official Records of said Riverside County;

THENCE South 34° 00' 00" East, along said last mentioned northeasterly line, a distance of 6.43 feet;

THENCE South 34° 53' 11" West, a distance of 134.21 feet;

THENCE South 34° 00' 00" East, parallel with the northeasterly line of said Lot 50, a distance of 6.00 feet;

THENCE South 56° 00' 00" West, a distance of 10.00 feet to said northeasterly line of Lot 50;

THENCE North 34° 00' 00" West, along said last mentioned northeasterly line, a distance of 14.00 feet to the POINT OF BEGINNING.

TOGETHER WITH the right to clear and keep clear said easement and right-of-way from any structures or trees, to enter upon and to pass and repass over and along said real property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees, whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said electric energy distribution facilities.



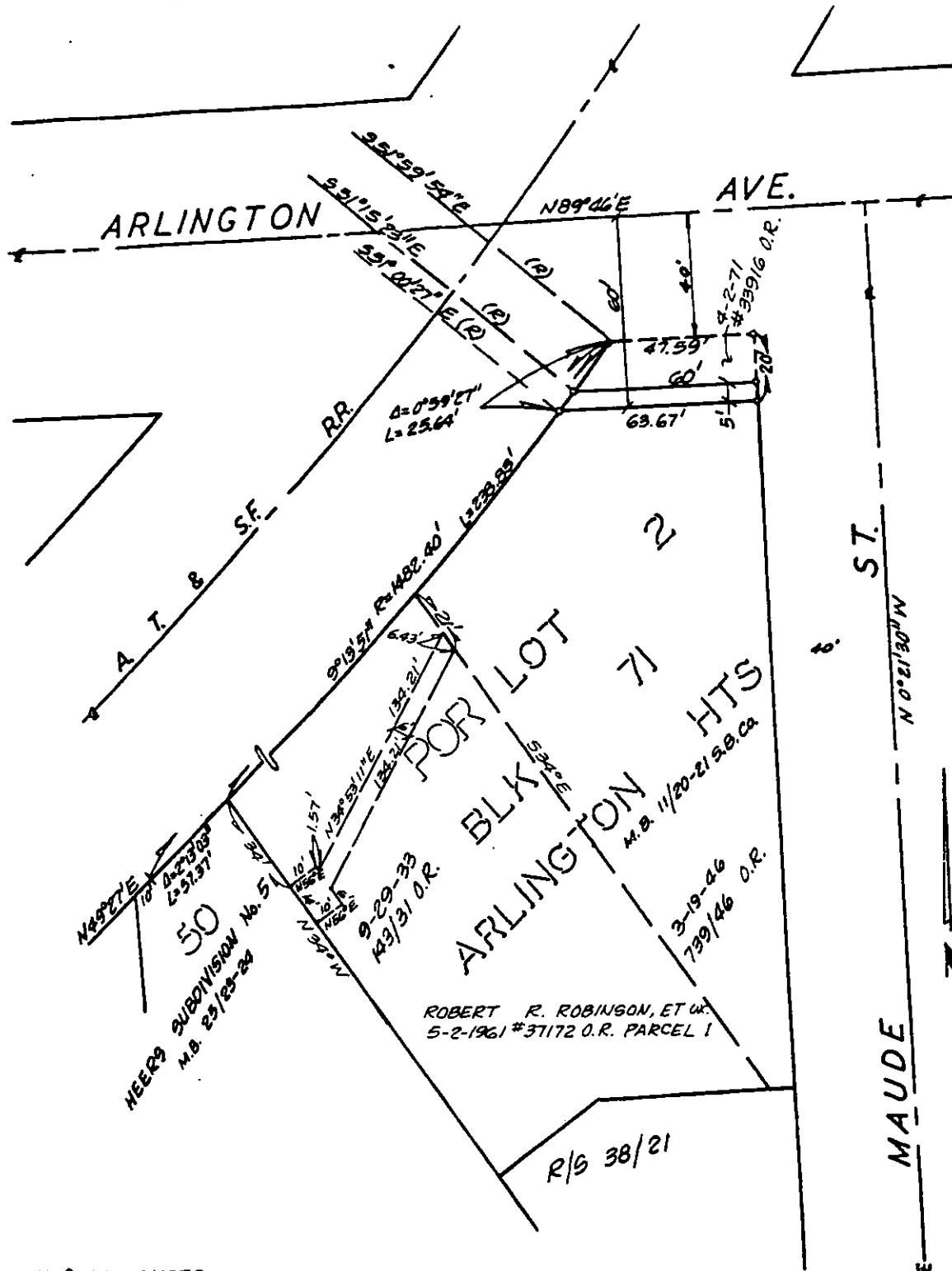
CONSENT TO RECORDATION
