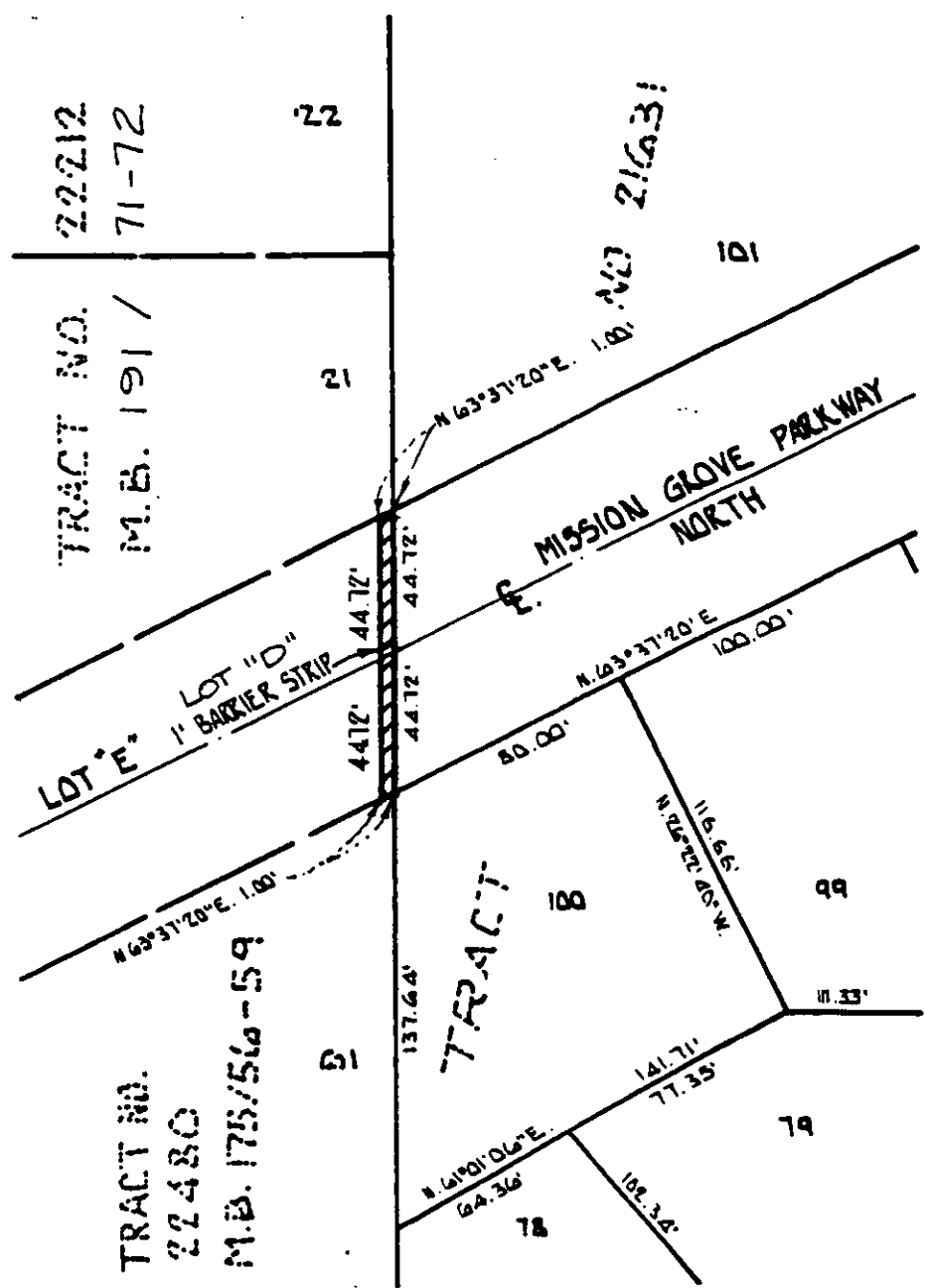

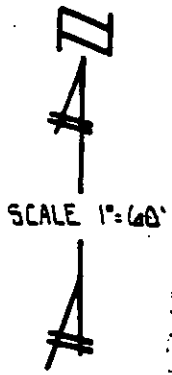

1' BARRIER STRIP



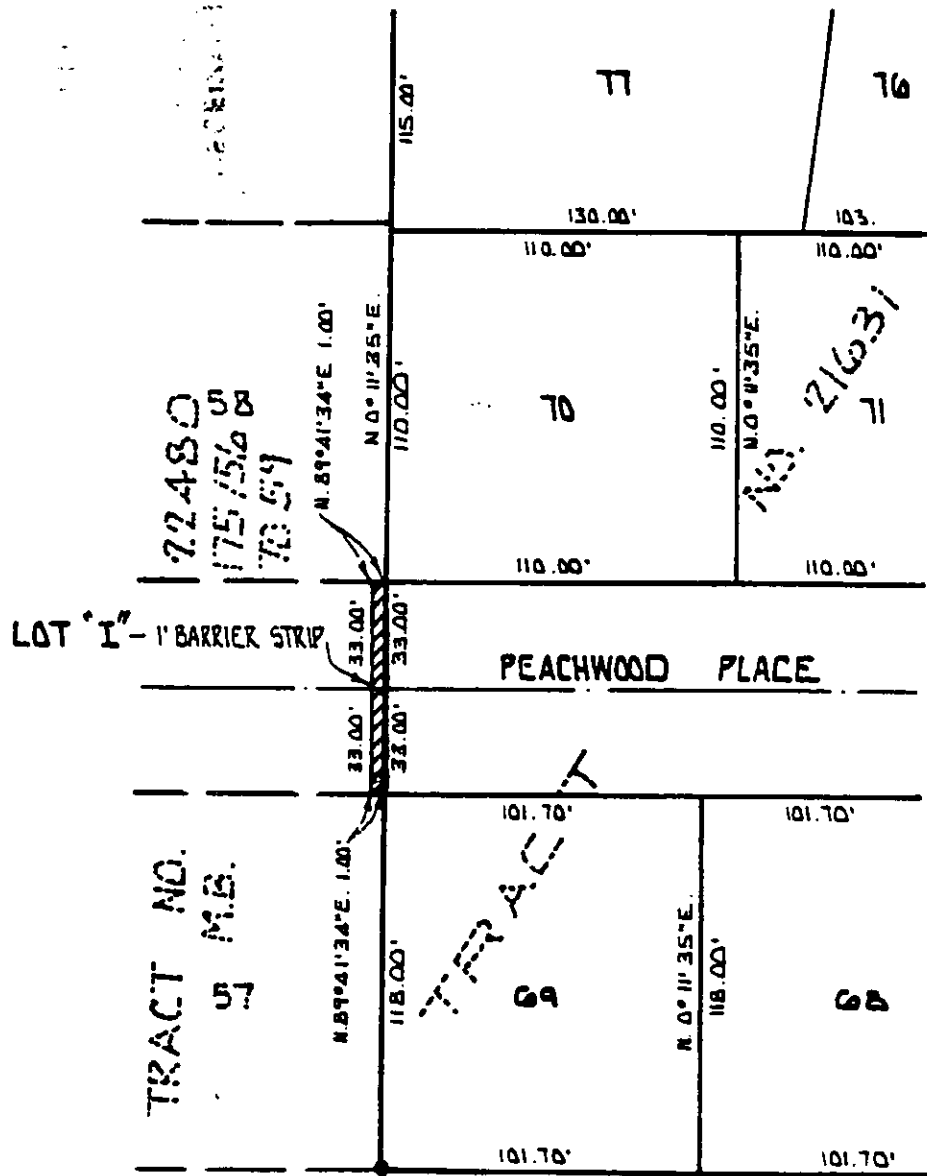

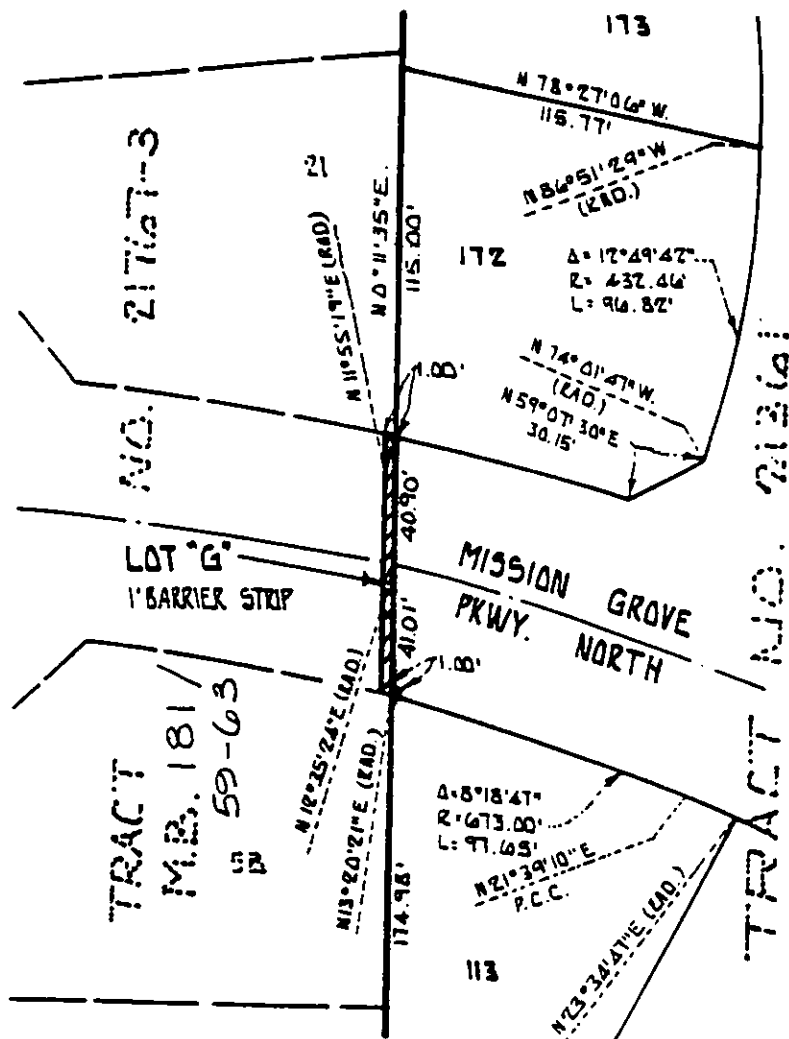
