E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, THOMAS R. NAPOLI and MARTHA E. NAPOLI, husband and wife as joint tenants, as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of storm drain facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 5 of Tract No. 2648, as shown by map on file in Book 50, Pages 18 through 20 of Maps, records of Riverside County, California, described as follows:

COMMENCING at the most northerly corner of said Lot;

THENCE South 72° 10' 00" West, along the northwesterly line of said Lot, a distance of 10.10 feet to a line which is parallel with and distant 10.00 feet westerly, as measured at right angles, from the easterly line of said Lot and the POINT OF BEGINNING of the parcel of land being described; said parallel line also being the westerly line of that certain easement conveyed to the City of Riverside for storm drain and sanitary sewer facilities by Easement Deed recorded June 2, 1961, as Instrument No. 47207 of Official Records of said Riverside County;

THENCE South 09° 47' 40" East, along said parallel line, a distance of 81.80 feet to the southeasterly line of said Lot;

THENCE South 72° 10' 00" West, along said southeasterly line, a distance of 11.00 feet;

THENCE North 12° 30' 24" West, a distance of 44.55 feet to a line parallel with and distant 23.00 feet westerly, as measured at right angles, from said easterly line of Lot 5;

THENCE North 09° 47' 40" West, along said last mentioned parallel line, a distance of 37.00 feet to said northwesterly line of Lot 5;

THENCE North 72° 10' 00" East, along said northwesterly line, a distance of 13.13 feet to the POINT OF BEGINNING.

Area - 1,016.2 square feet.

TOGETHER WITH the right to clear and keep clear said easement and right-of-way from any structures or trees, to enter upon and to pass and repass over and along said property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees, whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said storm drain facilities.


