TREE PLANTING EASEMENT

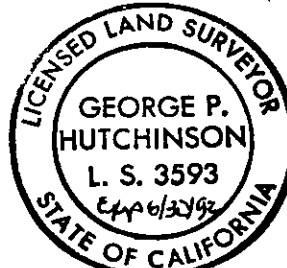

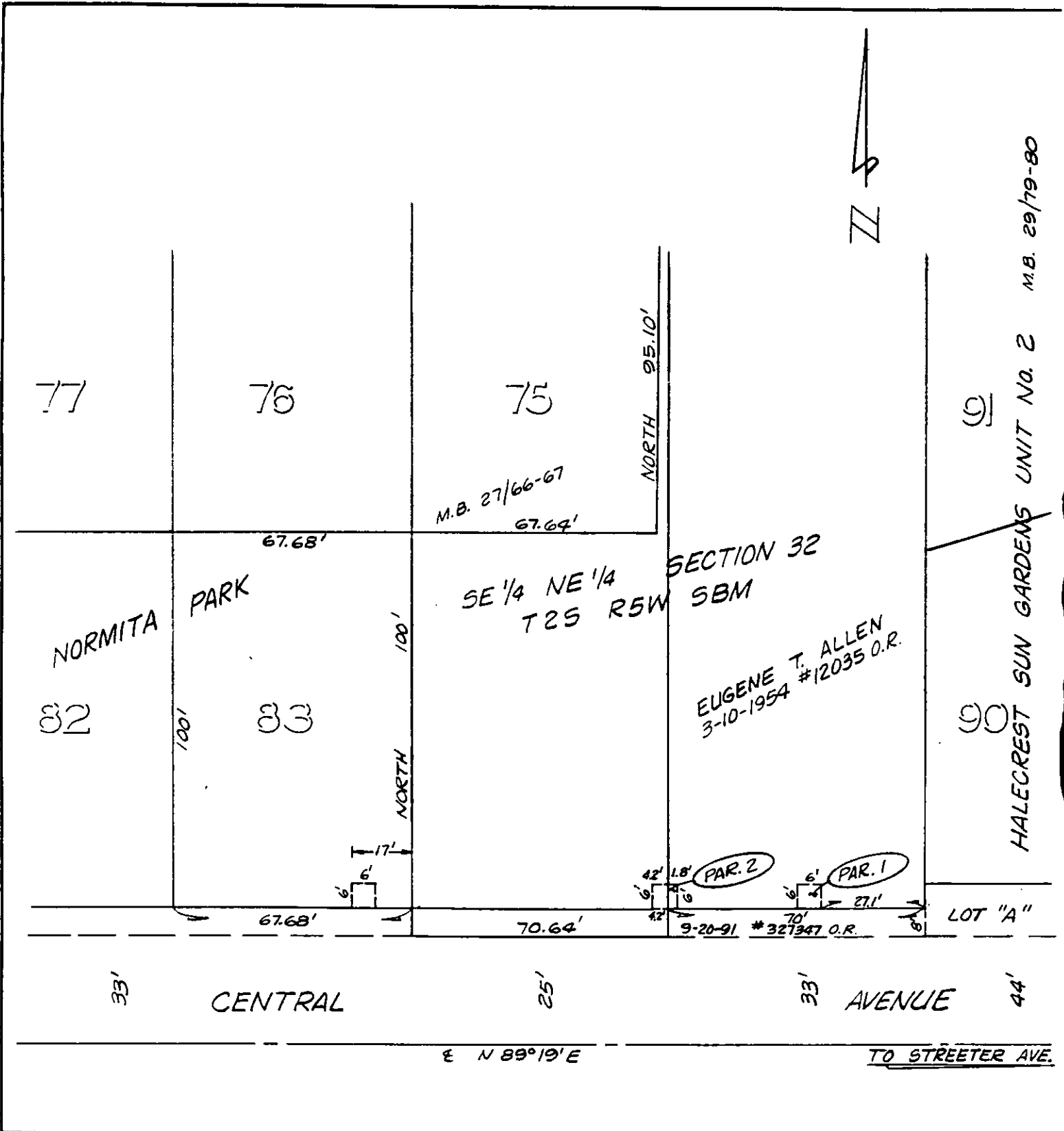
CONSENT TO RECORDATION
