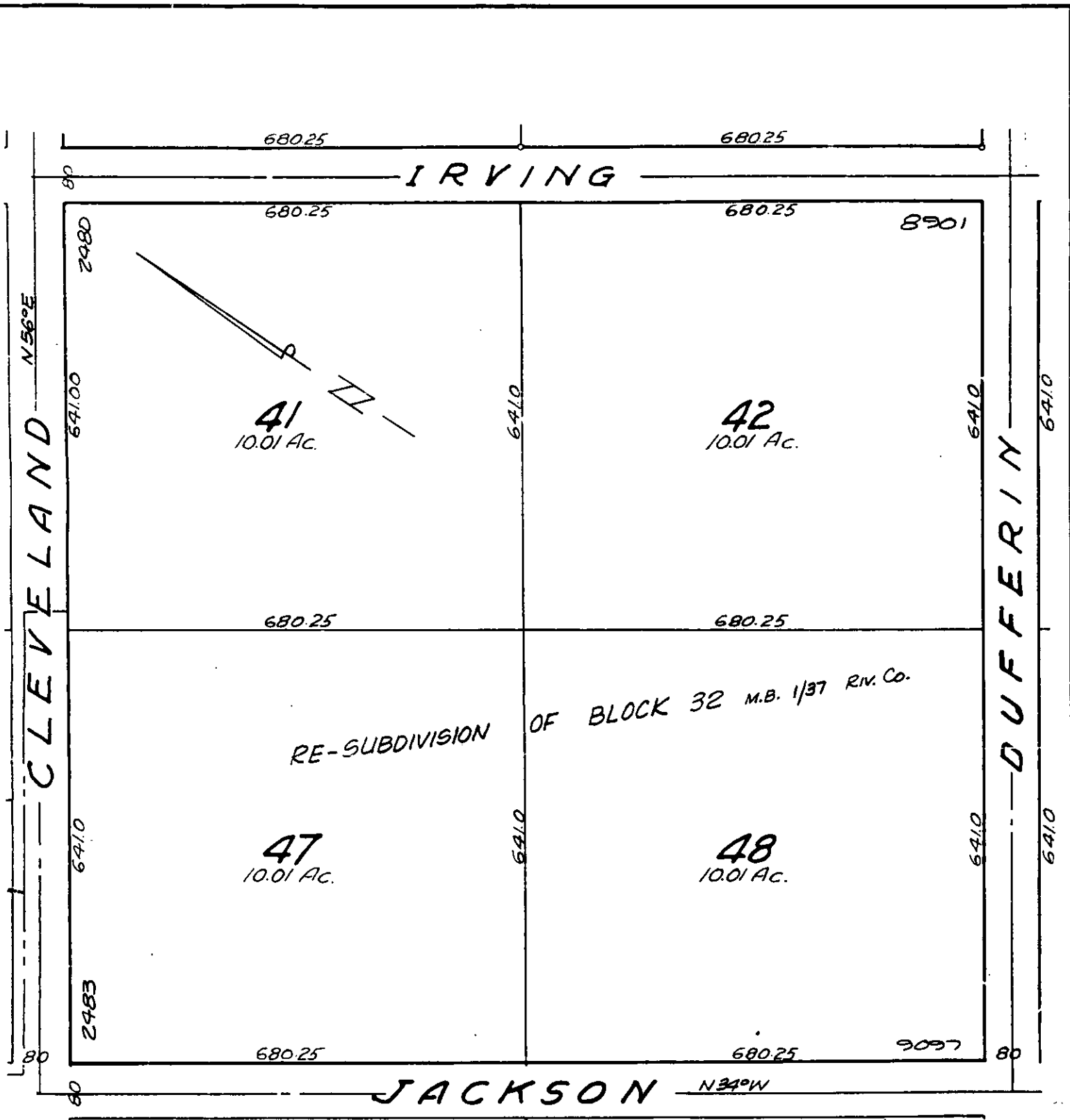
CONSENT TO RECORDATION
