Area - 40 acres, more or less.





CONSENT TO RECORDATION

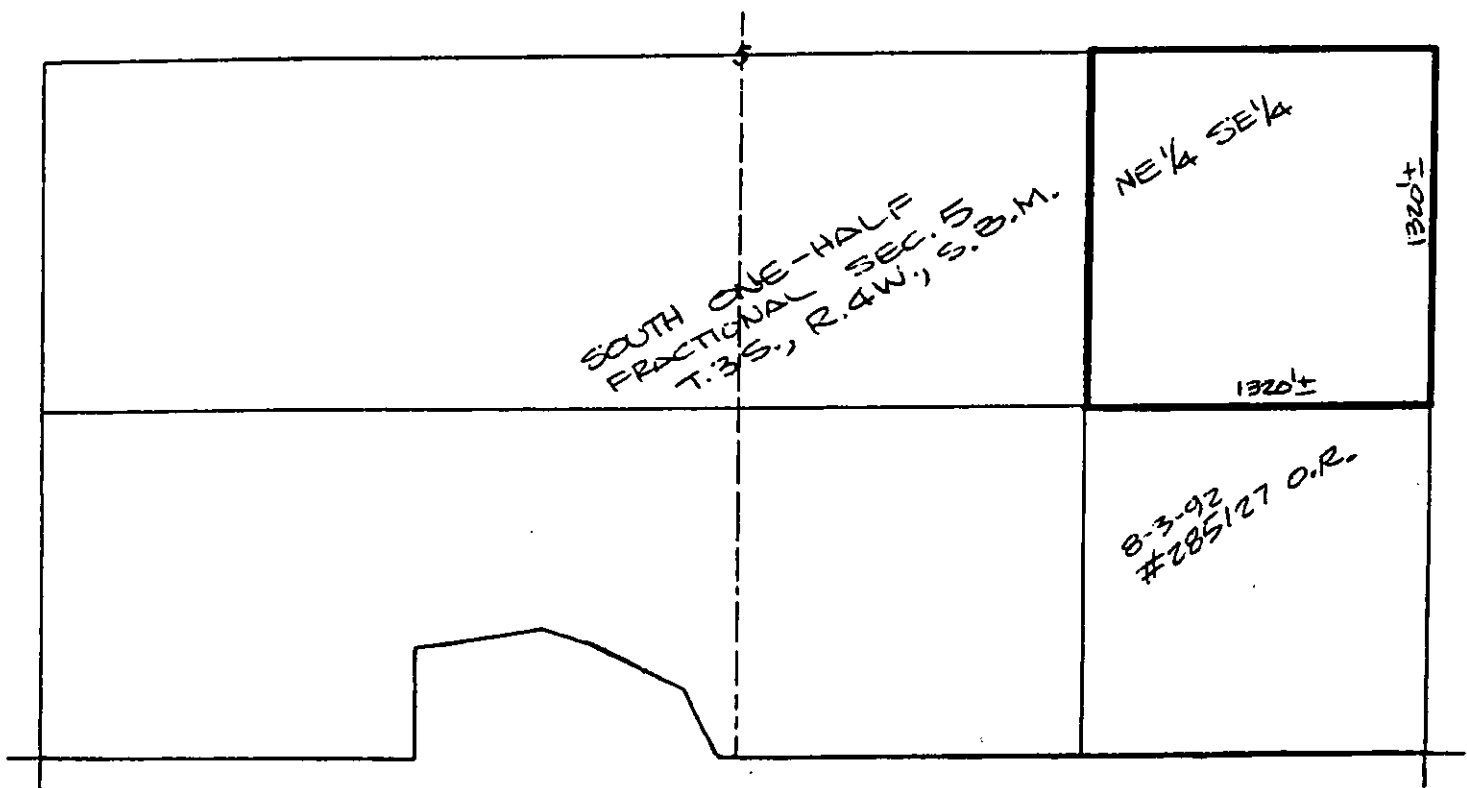
