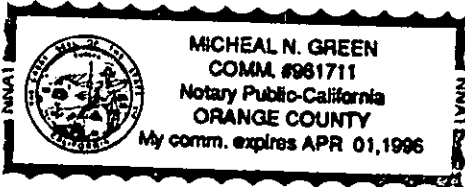

Those portions of Lot 3 of **LINDEN SQUARE** as shown by map on file in Book 31 of Maps, page 62 thereof, records of Riverside County, California, described as follows:

Parcel 1

BEGINNING at the southeast corner of said Lot 3;

THENCE South $89^{\circ}18'50''$ West, along the south line of said lot, a distance of 9.86 feet to the beginning of a tangent curve concave northwesterly and having a radius of 10.00 feet; the radial line to said beginning bears South $00^{\circ}41'10''$ East;

THENCE northeasterly, along said curve, an arc length of 15.57 feet through a central angle of $89^{\circ}13'15''$ to a point in the east line of said Lot 3;

THENCE South $00^{\circ}05'35''$ West, along said east line, a distance of 9.86 feet to said **POINT OF BEGINNING**.

Area: 20.8 square feet

Parcel 2

COMMENCING at the southeast corner of said Lot 3;

THENCE North $00^{\circ}05'35''$ East, along the east line of said lot, a distance of 15.42 feet to the **TRUE POINT OF BEGINNING**; said point being the beginning of a tangent curve concave southwesterly and having a radius of 19.50 feet;

THENCE northwesterly, along said curve, an arc length of 10.68 feet through a central angle of $31^{\circ}23'18''$ to the beginning of a reverse curve concave easterly and having a radius of 42.00 feet; the radial line to said point bears North $58^{\circ}42'17''$ East;

THENCE northwesterly, northerly and northeasterly, along said curve, an arc length of 46.02 feet to the beginning of a reverse curve concave northwesterly and having a radius of 19.50 feet; the radial line to said curve bears South $58^{\circ}31'07''$ East;

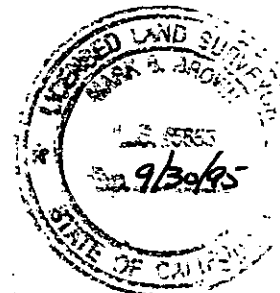
THENCE northeasterly, along said curve, an arc length of 10.68 feet through a central angle of $31^{\circ}23'18''$ to said east line of Lot 3;

THENCE South 00°05'35" West, along said east line, 64.00 feet to said TRUE POINT OF BEGINNING.

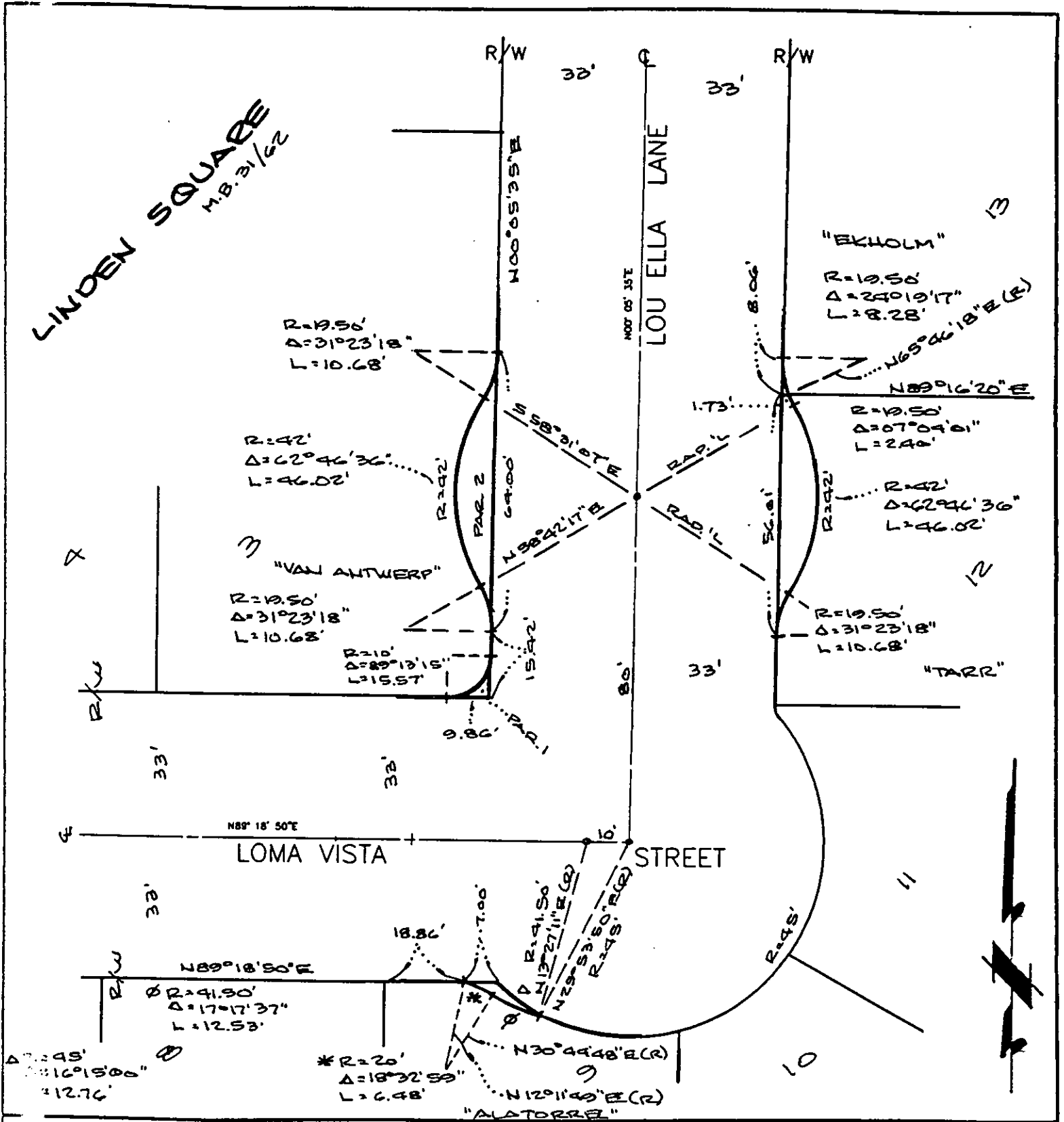
