TEMPORARY CONSTRUCTION  
EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, **LA SIERRA COLLEGE**, a California corporation, as Grantor, grants to the CITY OF RIVERSIDE, a municipal corporation of the State of California, as Grantee, its successors and assigns, a temporary easement and right-of-way for the construction and installation of **electrical energy distribution facilities**, together with all necessary appurtenances, in, under, upon, over and along that certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

**A strip of land 20.00 feet in width in that portion of Lots 1, 3, 5 and 7 in Block 57 of LA SIERRA HEIGHTS TRACT No. 2 as shown by map on file in Book 7 page 66 of Maps, records of Riverside County, California, the northeasterly line of said 20.00 foot wide strip being described as follows:**

**COMMENCING** at the intersection of the southeasterly line of Pierce Street (Lot I) with the southwesterly line of La Sierra Avenue (formerly Holden Avenue) (Lot T) as shown by said map of La Sierra Heights No. 2;

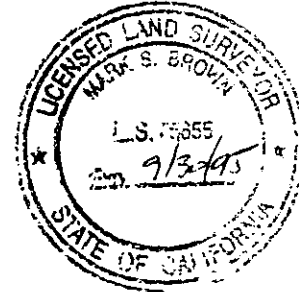
**THENCE** southwesterly, along said southeasterly line of Pierce Street, 335.05 feet to the **TRUE POINT OF BEGINNING**;

**THENCE** southeasterly, in a direct line, 1548 feet, more or less, to a point in the southeasterly line of said Lot 1 in Block 57; said point being distant thereon, 335.20 feet southwesterly from the most easterly corner of said Lot 1; said point being the **END** of this line description.

**EXCEPTING THEREFROM** the northwesterly 220 feet thereof.

This description was prepared by me or under my direction in conformance with the requirements of the Land Surveyors Act.

Said temporary construction easement is to be used for all purposes proper and convenient in the construction and installation of **electrical energy distribution facilities**, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

Upon completion of construction, the City of Riverside shall remove all debris, waste or excess material, brush or other matter or material deposited or placed upon the land, and with the exception of vegetation, return the surface as near as possible to its condition before construction.

This construction easement shall terminate upon completion of the work of constructing the **electrical energy distribution facilities** or within one year of the date of recording this document, whichever occurs first.

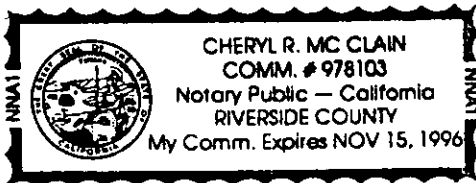
