BE IT RESOLVED by the City Council of the City of Riverside, California, that the name of those portions of Pennsylvania Avenue and Box Springs Boulevard situated between the easterly terminus of Fourteenth Street and the 215/60 Freeway, described as follows:

That portion of that certain street known as Pennsylvania Avenue and that portion of that certain street known as Box Springs Boulevard, lying easterly of a line parallel with and distant 431.05 feet westerly, as measured at right angles, from the centerline of Kansas Avenue, as shown by map of University Estates Unit No. 3, on file in Book 26, Page 63 of Maps, records of Riverside County, California, and lying westerly of that certain parcel of land shown as Segment 1 of Map of Relinquishment on file in Book 4, Page 64 of State Highway Maps, records of said Riverside County,

be changed to MARTIN LUTHER KING BOULEVARD.

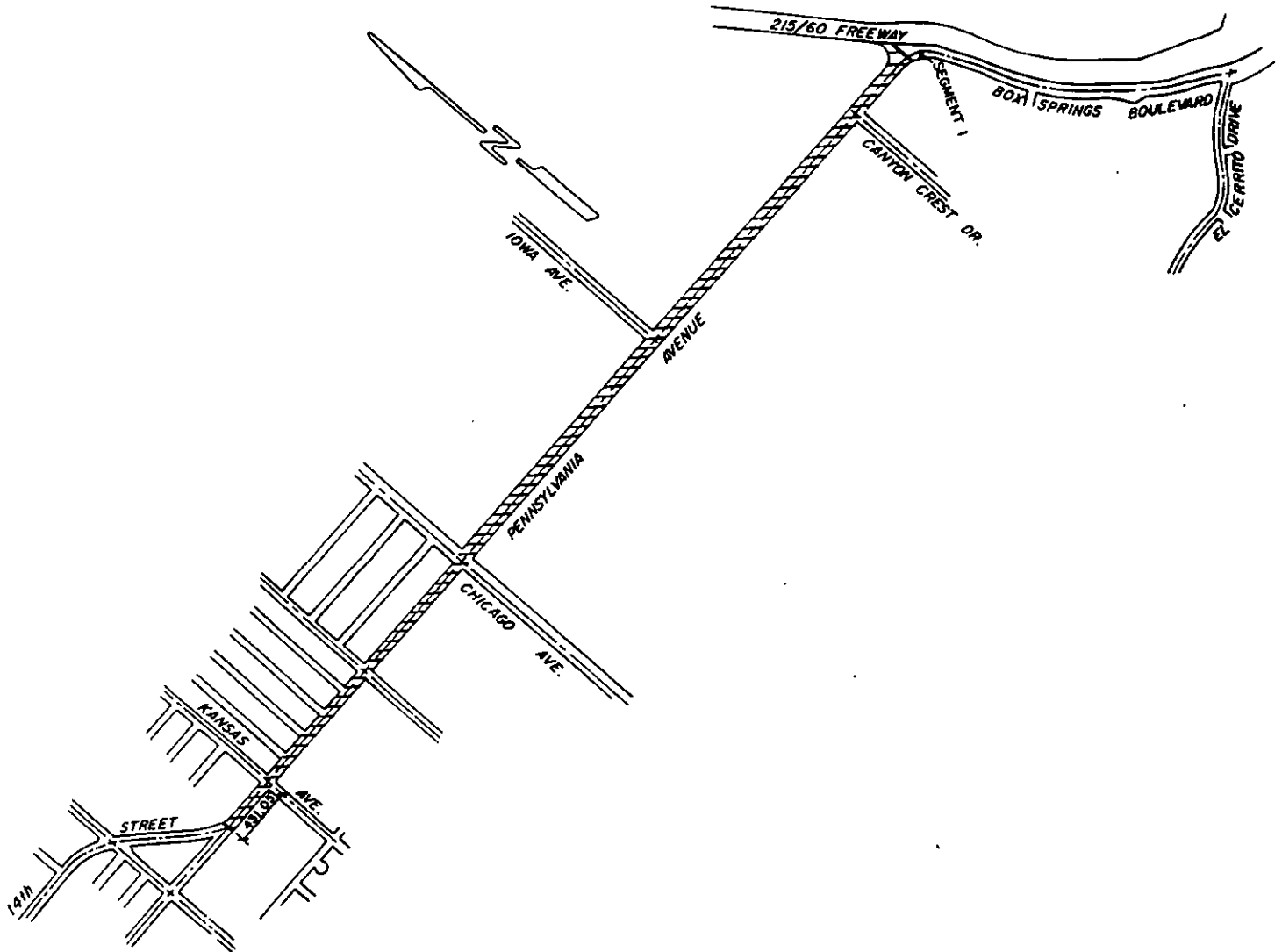
