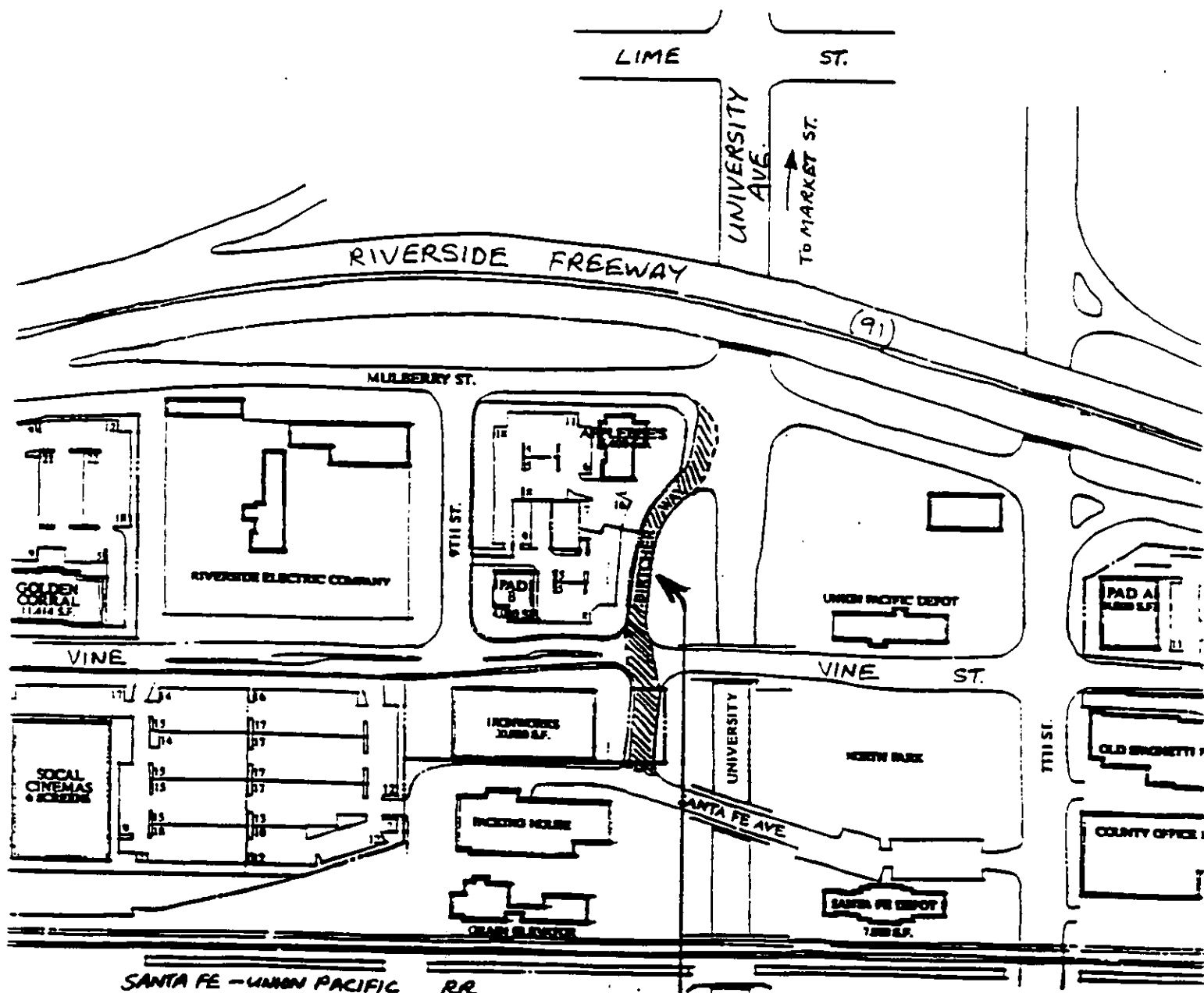


EXHIBIT 1
