EASEMENT



constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said *roadway slope and drainage facilities*.

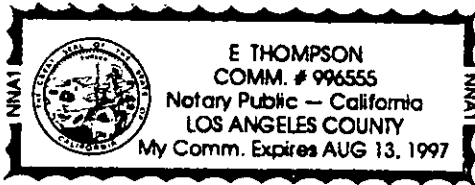



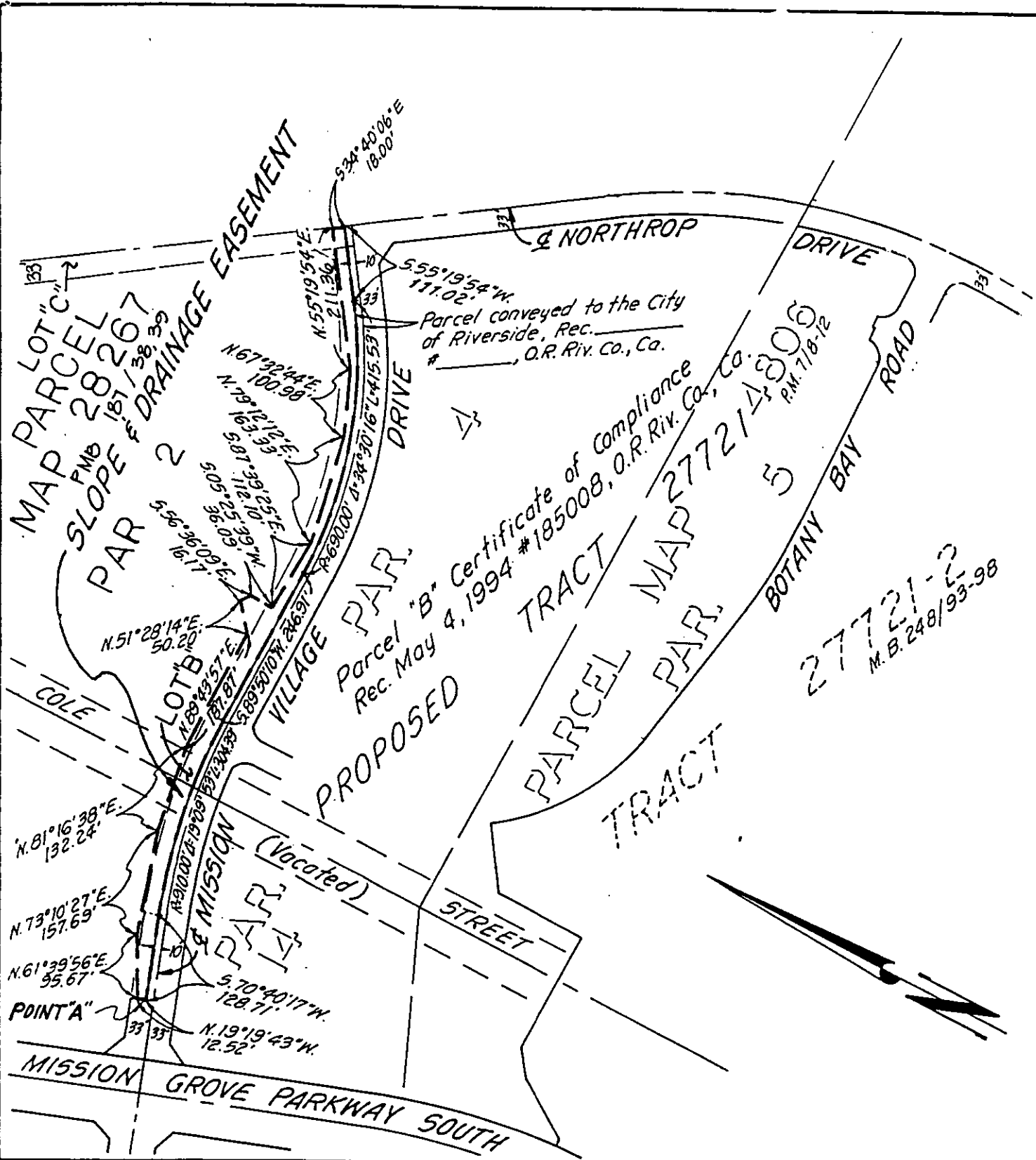
