RIGHT OF WAY QUITCLAIM DEED

This Indenture, made and entered into this 20th day of August in the year nineteen hundred and thirty-five between the RIVERSIDE WATER COMPANY, a corporation duly organized and existing under the laws of the State of California, party of the first part and RIVERSIDE COUNTY, a political subdivision of the State of California, party of the second part,

WITNESSETH: That in pursuance of a resolution duly passed by the Board of Directors of said corporation, at a meeting of said Board of Directors duly assembled, and for and in the actual consideration of the sum of One and no/100 Dollars to it paid by the said party of the second part, the receipt of which is hereby acknowledged, the said party of the first part does by these presents remise, release and forever quitclaim to the County of Riverside, party of the second part, the following described easement for public highway and public utility purposes, situated in the said County of Riverside, State of California, to-wit:

All of the right of way of Lower Canal of the Riverside Water Company, which is included within the following described real property;

A portion of Lots 1, 2, 3, 4, 16, 17 and 17 1/2, as said Lots are shown on map of Addition to Bandini Donation, filed in Book 1 of Record of Surveys at Page 3 thereof, Riverside County Records, and a portion of Lots 142, and the unnumbered Lot lying northwesterly of Lot 148 as shown on map of the Southern California Colony Association Lands recorded in Map Book 7, page 3 records of San Bernardino County, California, being more particularly described as follows by metes and bounds:

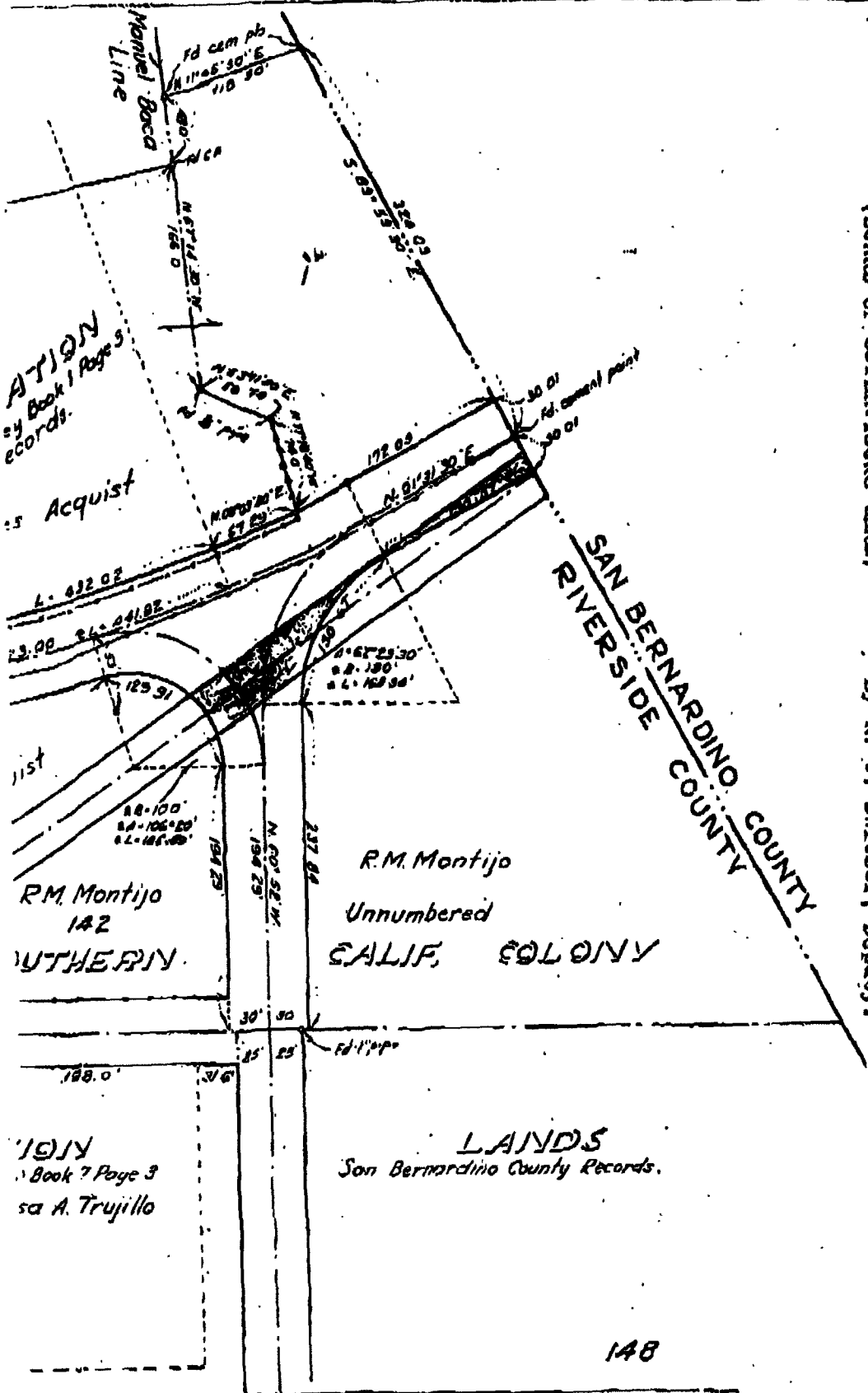

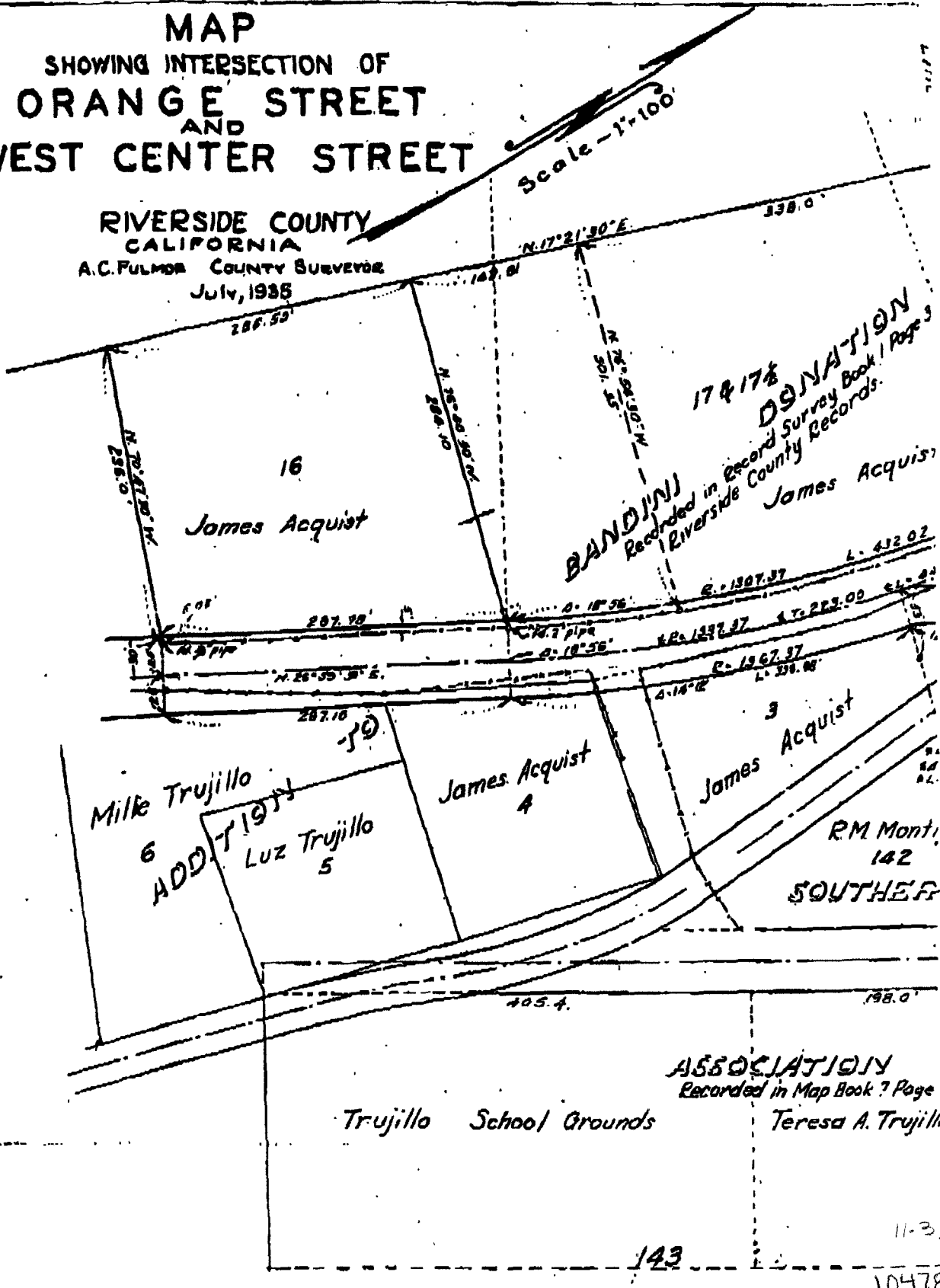
