## RESOLUTION NO. 19099

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 18283 WHICH ACCEPTED PORTIONS OF OFFERS OF DEDICATION OF CERTAIN REAL PROPERTY FOR PUBLIC STREET AND PUBLIC UTILITY PURPOSES TO BECOME AND BE KNOWN AS PORTIONS OF LANCE DRIVE AND SYCAMORE CANYON DRIVE TO CORRECT THE NAME FROM SYCAMORE CANYON DRIVE TO SYCAMORE CANYON BOULEVARD.

WHEREAS in connection with the finalization of parcel map waiver Case PMW-10-912, certain real property was irrevocably offered for dedication to the City of Riverside for public street and public utility purposes, together with all rights to construct and maintain public street and public utility improvements consistent with the use as a public street, by THE LANCE FAMILY REVOCABLE TRUST, dated August 14, 1981, in that Offer of Dedication dated May 4, 1992 and recorded July 2, 1992 as Instrument No. 246723, Official Records of Riverside County, California; and

WHEREAS also in connection with the finalization of parcel map waiver Case PMW-10-912, certain real property was irrevocably offered for dedication to the City of Riverside for public street and public utility purposes, together with all rights to construct and maintain public street and public utility improvements consistent with the use as a public street, by SPECTRUM ASSOCIATES NO. 1, a California general partnership, in that Offer of Dedication dated April 29, 1992, and recorded July 2, 1992 as Instrument No. 246725, Official Records of Riverside County, California; and WHEREAS in connection with the finalization of

Parcel Map 162, certain real property was irrevocably offered for dedication to the City of Riverside for public street and highway purposes, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway, by JOSEPHINE G. BARKER, a widow, as to an undivided one half interest, and MIGUEL J. GARAT and EDITH GARAT, husband and wife, as joint tenants, as to an undivided one half interest, in that Offer of Dedication dated December 18, 1974, and recorded January 10, 1975 as Instrument No. 3442, Official Records of Riverside County, California; and

WHEREAS by Resolution No. 18283 adopted on July 6, 1993, portions of the Offers of Dedication above-mentioned were accepted for street, utility and highway purposes to become and be known as portions of Lance Drive and Sycamore Canyon Drive in order to proceed with street improvements and installation of utilities to provide access to and service for the Smith's Food Distribution Center at the westerly terminus of Eastridge Avenue adjacent to Sycamore Canyon Park within the Sycamore Canyon Business Park;

WHEREAS Resolution No. 18283 was recorded in the Office of the Recorder of Riverside County, California on July 26, 1993, as Instrument No. 285812, Official Records of Riverside County, California; and

WHEREAS the correct name of the one street is

Sycamore Canyon Boulevard rather than Sycamore Canyon Drive;
and

WHEREAS it would be appropriate to amend Resolution No. 18283 to reflect the correct name of the street;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: Section 3 of Resolution No. 18283 is hereby amended to read as follows:

"Section 3: That the hereinafter described real property irrevocably offered for dedication in the Offer of Dedication signed by JOSEPHINE G. BARKER, a widow, as to an undivided one half interest, and MIGUEL J. GARAT and EDITH GARAT, husband and wife, as joint tenants, as to an undivided one half interest, on the 18th day of December, 1974 and recorded January 10, 1975, as Instrument No. 3442, Official Records of Riverside County, California, is hereby accepted by the City of Riverside for public street and highway purposes to become and be known as a portion of Sycamore Canyon Boulevard, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway. The aforementioned real property accepted by the City of Riverside for public street and highway purposes is situated within the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of that certain Offer of Dedication for public street and highway purposes, conveyed to the City of Riverside, a municipal corporation, by document recorded January 10, 1975, as Instrument No. 3442 of Official Records of Riverside County, California, described as follows:

The easterly 44.00 feet of Parcel 3 and Parcel 4 of Parcel Map on file in Book 18 of Parcel Maps, at page 70 thereof, records of Riverside County, California."

Section 2: The City Clerk of the City of Riverside, California, is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.
