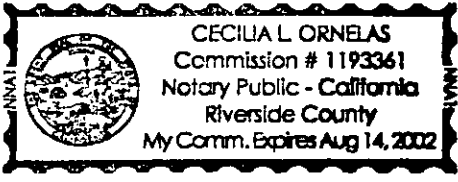



Thence South 89° 40' West, along the south line of said Bonnie Banks Tract, a distance of 14.64 feet;

Thence South 07° 24' West, a distance of 284.45 feet, to the northerly line of said Rancho El Sobrante de San Jacinto;

Thence South 34° 15' East, a distance of 60.92 feet, to the *POINT OF BEGINNING*;

Thence continuing South 34° 15' East, a distance of 87.35 feet, to the southeast corner of land described in document recorded September 4, 1987 as Instrument No. 258753, of Official Records of Riverside County, State of California;

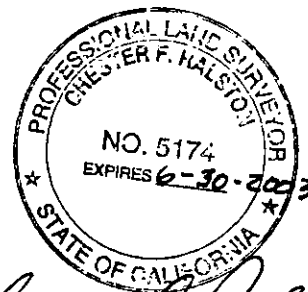

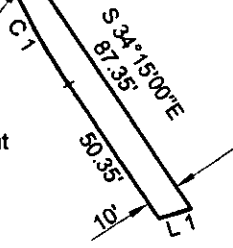
RANCHO LA SIERRA SEPULVEDA
