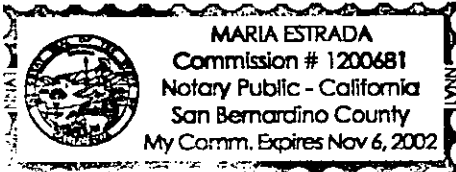

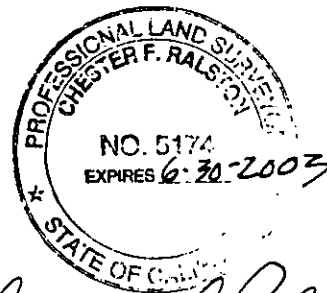

In the City of Riverside, County of Riverside, State of California, Lying within Fractional Section 15, Township 3 South, Range 6 West, S. B. M., as shown by map of Sectionalized Survey of Rancho El Sobrante De San Jacinto, on file in Book 1 of Maps, at Pages 8, records of San Bernardino County, State of California, described as follows:

Thence South 89° 40' West, along the south line of said Bonnie Banks Tract, a distance of 14.64 feet;

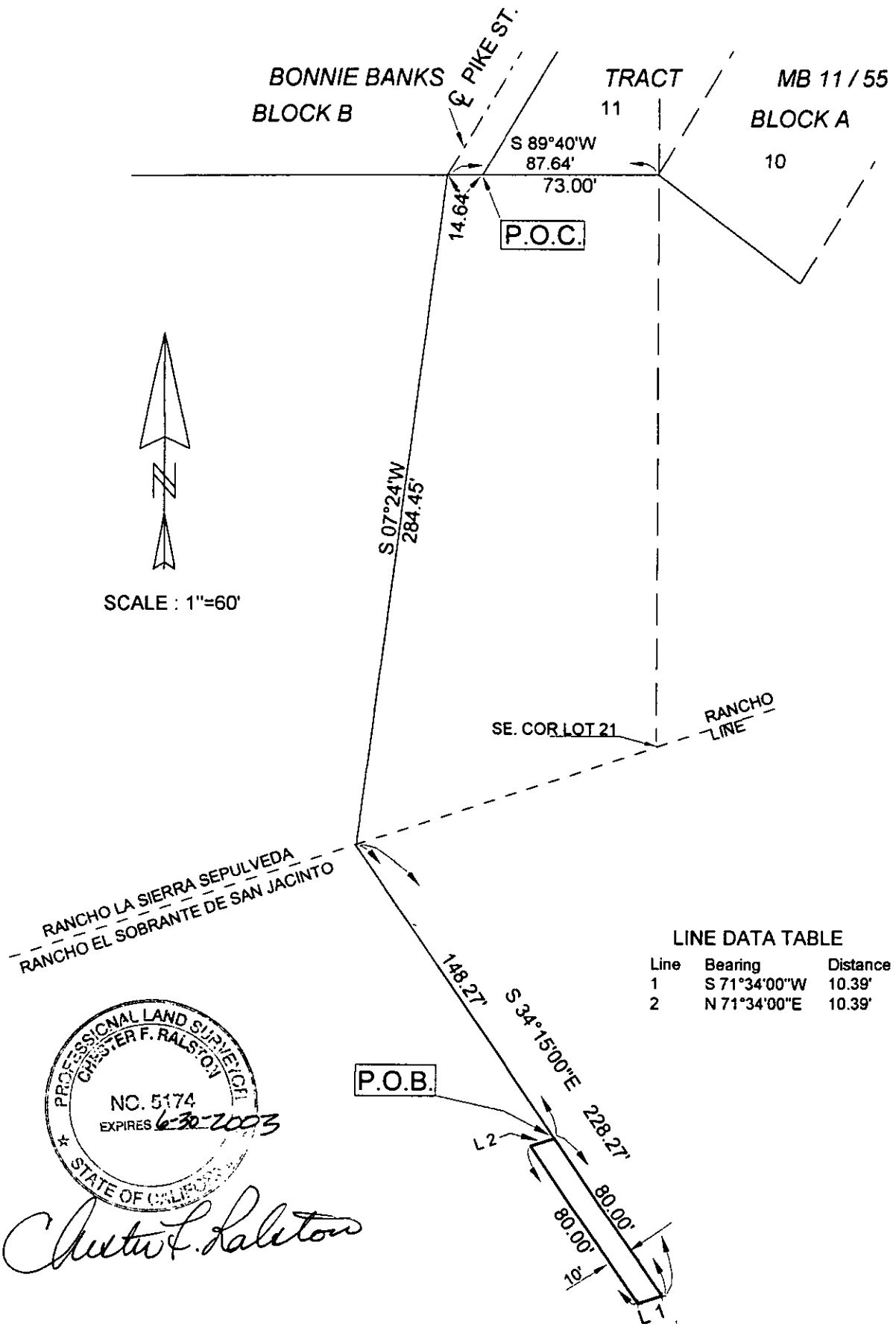

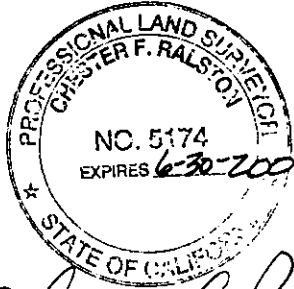
