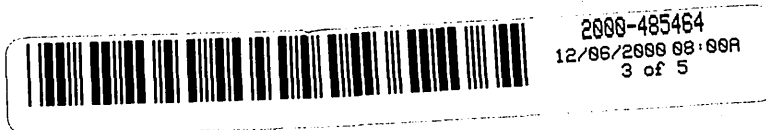


EXHIBIT "A"

That certain real property located in the City of Riverside, County of Riverside, State of California, and being a portion of Parcel 2 of Parcel Map No. 28938, as shown per map filed in Parcel Map Book 193, Pages 90-91, inclusive, Records of said Riverside County, described as follows:

BEGINNING at the most northerly corner of said Parcel 2;

THENCE along the northwesterly line of said Parcel 2 South 56°01'02" West a distance of 249.87 feet to a point on a non-tangent curve concave northerly and having a radius of 47.00 feet, a radial line to said point bears South 73°20'49" West;

THENCE southeasterly and northeasterly along said curve through a central angle of 128°34'42" and arc length of 105.47 feet;

THENCE North 34°46'07" East a distance of 49.68 feet to the beginning of a curve concave southeasterly and having a radius of 100.00 feet;

THENCE northeasterly along said curve through a central angle of 21°14'55" an arc length of 37.09 feet to a line which is parallel with and distant 33.00 feet southeasterly, as measured at right angles, from said northwesterly line of Parcel 2;

THENCE along said parallel line North 56°01'02" East a distance of 86.71 feet to the beginning of a non-tangent curve concave southerly and having a radius of 41.50 feet, a radial line to said beginning bears North 08°37'12" West:

THENCE easterly and southeasterly along said curve through a central angle of 36°12'42" an arc length of 26.23 feet to the end of said non-tangent curve at a point on the northeasterly line of said Parcel 2, a radial line to said end point bears North 27°35'30" East;

THENCE along said northeasterly line, North 33°59'33" West a distance of 50.75 feet to the POINT OF BEGINNING.

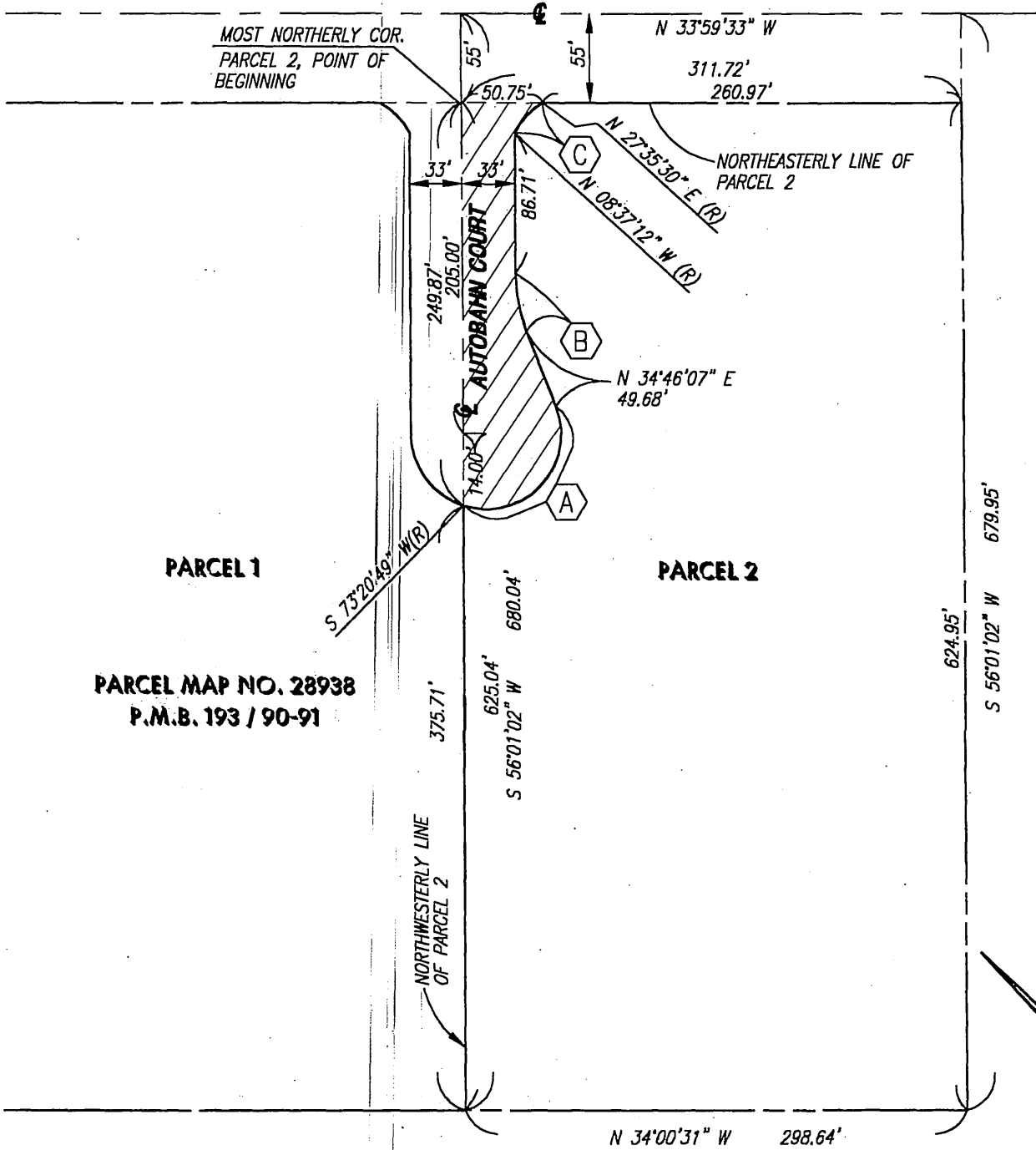
