A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE STREET NAME(S) OF COUNTRYSIDE COURT WITHIN RECORDED TRACT MAP 28866-1 TO *ORANGE TERRACE PARKWAY*; DAISY COURT LOCATED WITHIN TRACT MAP 28491-2 TO *ANGEL LANE*; AND BACH WAY LOCATED WITHIN RECORDED TRACT MAP 21638-3 TO *GABLE LANE*.

WHEREAS, three recently recorded tract maps require that the names of three street segments be changed in order to avoid potential problems with mail delivery and emergency vehicle response; and

WHEREAS, none of the proposed street name changes have residences addressed to them and the affected developers and engineers are agreeable to the street name changes.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the street name for Countryside Court located within recorded Tract Map 28866-1 be changed to *Orange Terrace Parkway*; the street name for Daisy Court located within Tract Map 28491-2 be changed to *Angel Lane*; and the street name for Bach Way located within recorded Tract Map 21638-3 be changed to *Gable Lane*, in the City Limits of the City of Riverside, and as more specifically set forth in the attached Exhibit "A", and incorporated herein by reference.

BE IT FURTHER RESOLVED that the City Clerk of the City of Riverside is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.



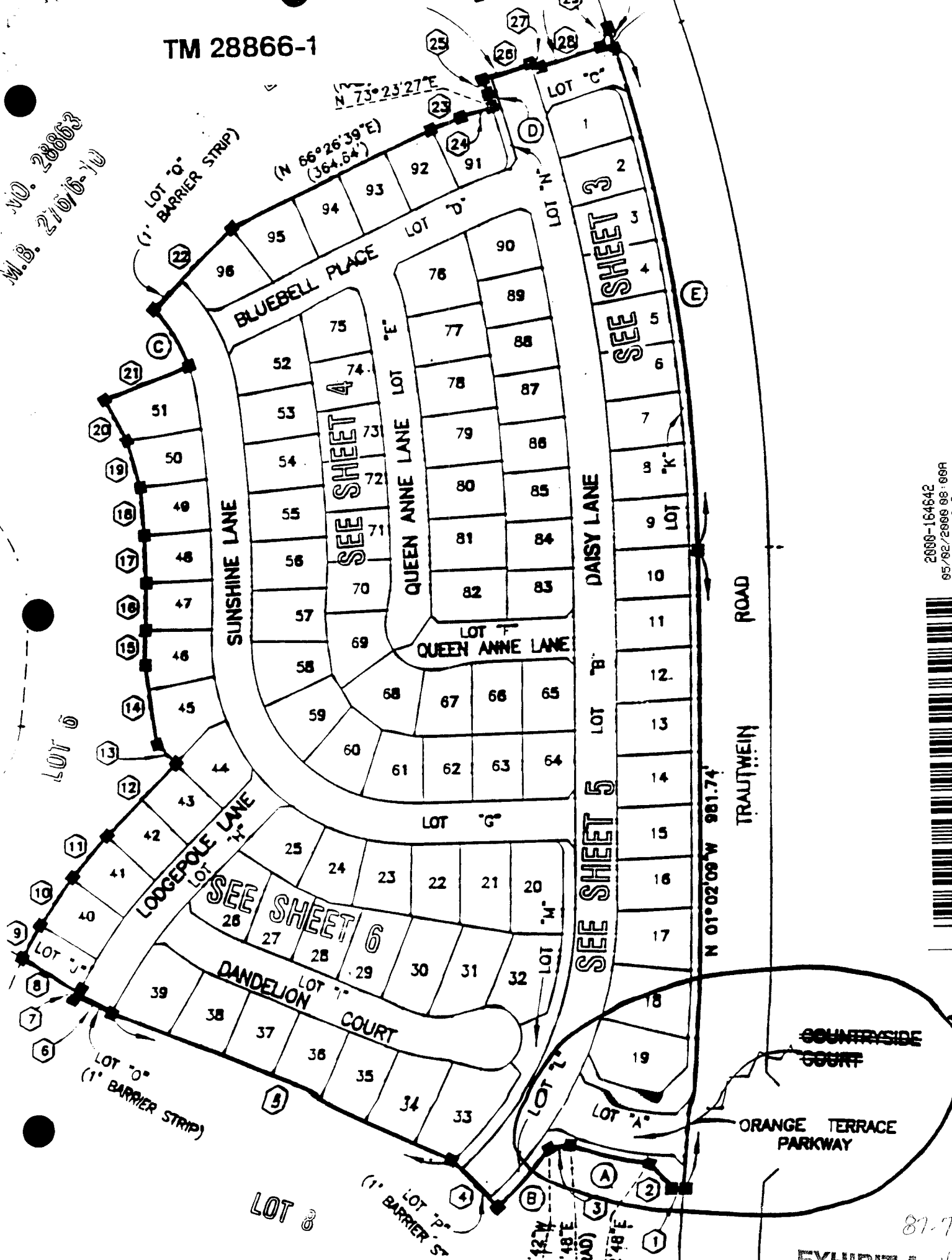
