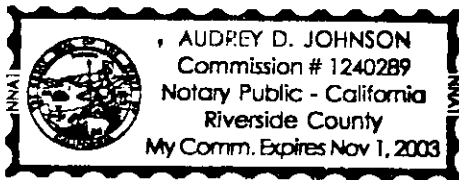



THENCE North 87°49'22" West, continuing along said southerly line, a distance of 6.55 feet;

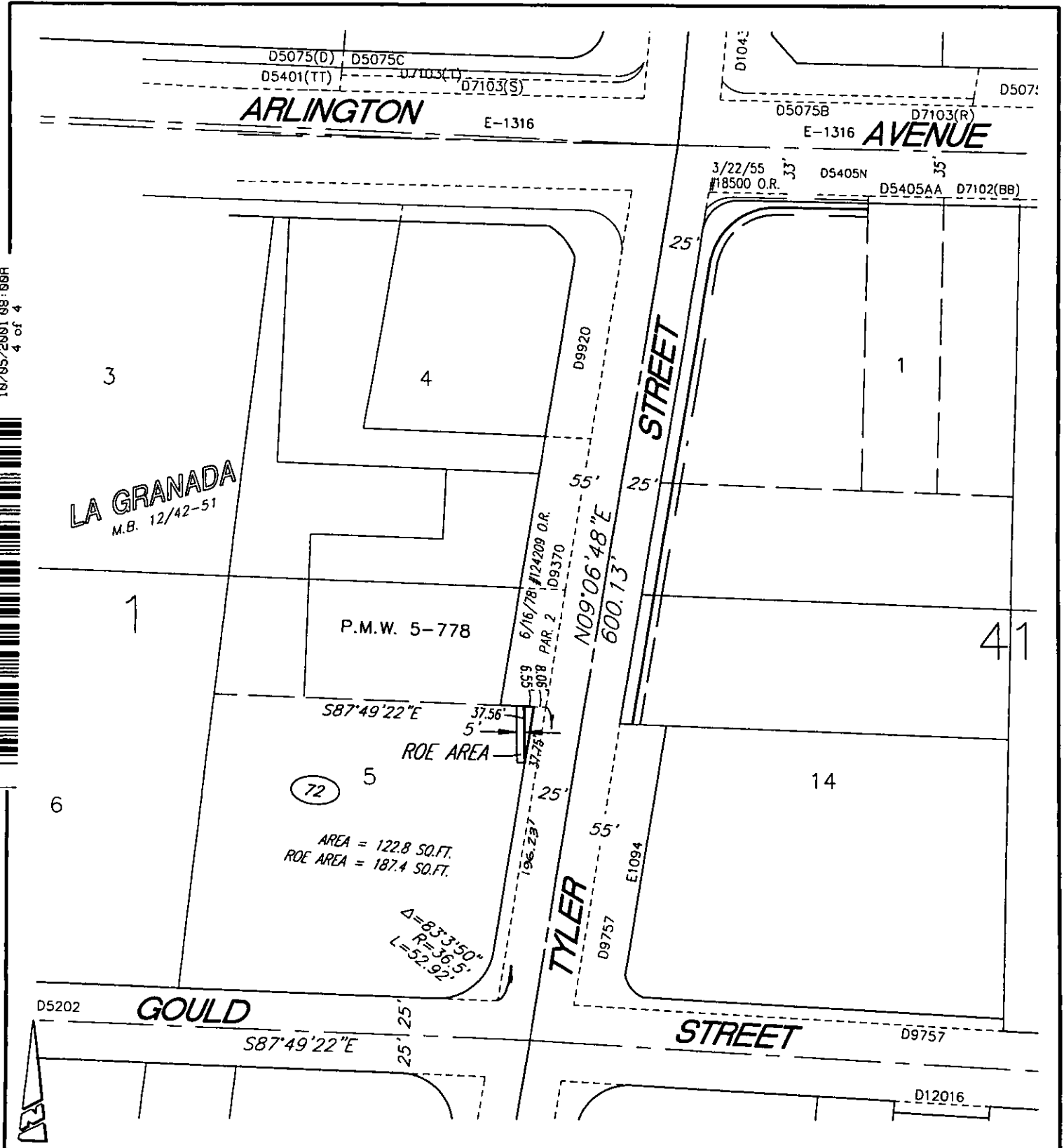
