RESOLUTION NO. 19726

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE STREET NAME OF THAT PORTION OF APPROXIMATELY 870-FOOT LONG SECTION OF GOLDEN AVENUE EXTENDING SOUTHERLY FROM PIERCE STREET TO BE NAMED "RIVERWALK PARKWAY" AND REPEALING RESOLUTION NO. 19650.

WHEREAS, Griffin Industries has requested a street name change for an approximately 870-foot long section of Golden Avenue extending from Pierce to "Riverwalk Parkway" which will connect to a new 110-foot arterial street of that same name as set forth herein; and

WHEREAS, the proposed street name change would also establish "Riverwalk Parkway" as the street name for a new 110-foot arterial street that will bisect the La Sierra University Specific Plan area; and

WHEREAS, the Planning Commission approved formally recognizing the proposed street name change on January 7, 2000; and

WHEREAS, the City Council adopted Resolution No. 19650 incorrectly changing the name of a portion of existing Pierce Street to Riverwalk Parkway on March 14, 2000, and that resolution is to be repealed with the adoption of this correcting resolution;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the street name change of an approximately 870 foot long section of Golden Avenue extending southerly from Pierce Street in the city limits of the City of Riverside, as more specifically set forth in the attached Exhibit "A", and incorporated herein by reference, be changed to **Riverwalk Parkway**.

BE IT FURTHER RESOLVED that Resolution No. 19650 adopted March 14, 2000, is hereby repealed.

BE IT FURTHER RESOLVED that the City Clerk of the City of Riverside is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.

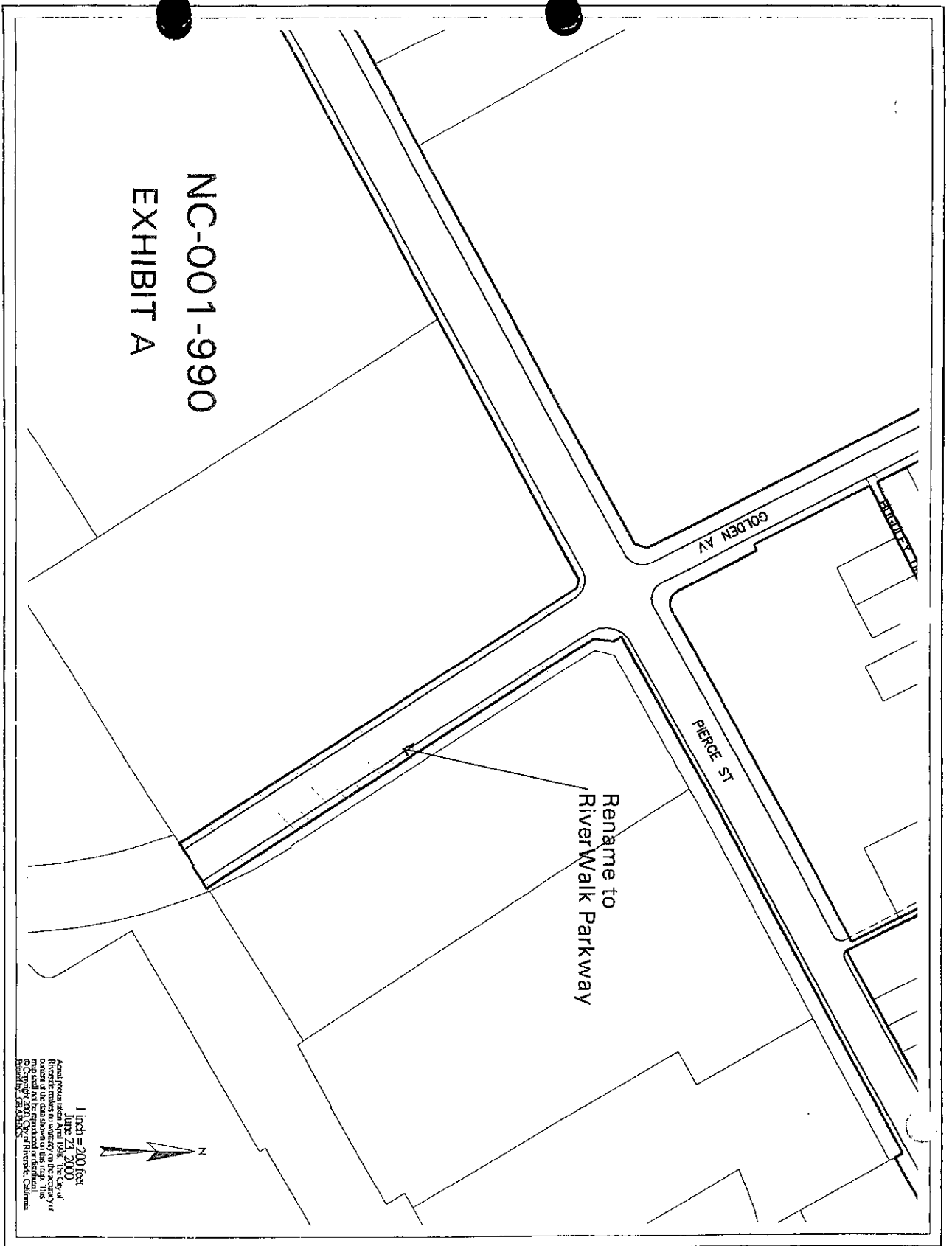
