EASEMENT

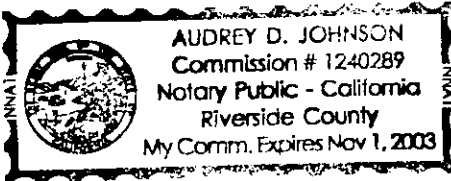

EXHIBIT "A"

That certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Block 15 of La Granada, as shown by map on file in Book 12, Pages 42 through 51 of Maps, records of Riverside County, California, described as follows:

COMMENCING at the most westerly corner of Parcel 3 of Record of Survey on file in Book 48, Page 26 of Record of Surveys, records of said Riverside County;

THENCE North 66°40'42" East, along the northwesterly line of said Parcel 3, a distance of 8.00 feet to a line that is parallel with and distant 33.00 feet northeasterly, as measured at right angles, from the centerline of Tyler Street (formerly Tyler Avenue) and the POINT OF BEGINNING of the parcel of land being described;

THENCE North 23°19'18" West, along said parallel line, a distance of 6.00 feet to a line that is parallel with and distant 6.00 feet northwesterly, as measured at right angles, from said northwesterly line of Parcel 3;


THENCE North 66°40'42" East, along said last mentioned parallel line, a distance of 30.00 feet;

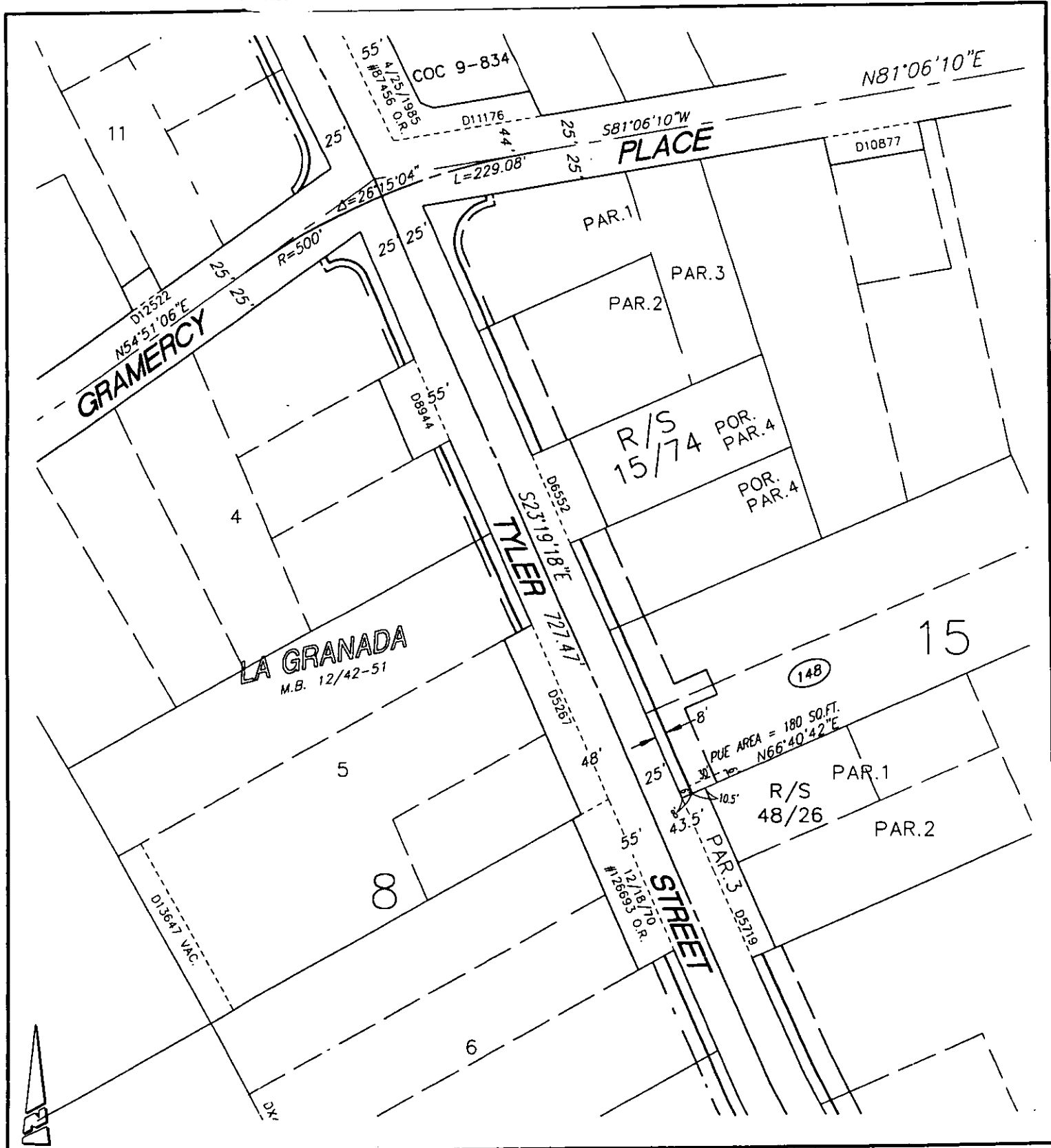
