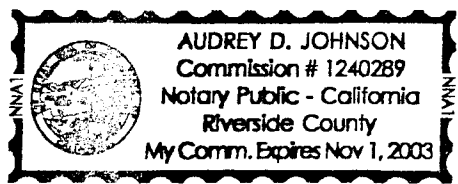

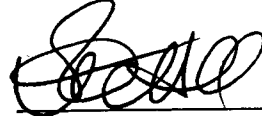

EXHIBIT "A"

That certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 10 in Block 16 of La Granada, as shown by map on file in Book 12, Pages 42 through 51 of Maps, records of Riverside County, California, described as follows:

COMMENCING at the southwesterly corner of said Lot 10;

THENCE North 26°15'39" West, along the southwesterly line of said Lot 10, a distance of 150.73 feet to the most westerly corner of that certain parcel of land described in deed to Richard E. Ayala, et ux., as Parcel 1 by document recorded June 23, 1994, as Instrument No. 256112 of Official Records of said Riverside County;

THENCE North 69°28'47" East, along the northerly line of said parcel of land, a distance of 8.04 feet to a line that is parallel with and distant 33.00 feet northeasterly, as measured at right angles, from the centerline of Tyler Street (formerly Tyler Avenue) and the POINT OF BEGINNING of the parcel of land being described;

THENCE South 26°15'39" East, along said parallel line, a distance of 4.02 feet;



THENCE North 69°28'47" East, along a line that is parallel with said northerly line, a distance of 3.01 feet to a line that is parallel with and distant 36.00 feet northeasterly, as measured at right angles, from said centerline of Tyler Street;

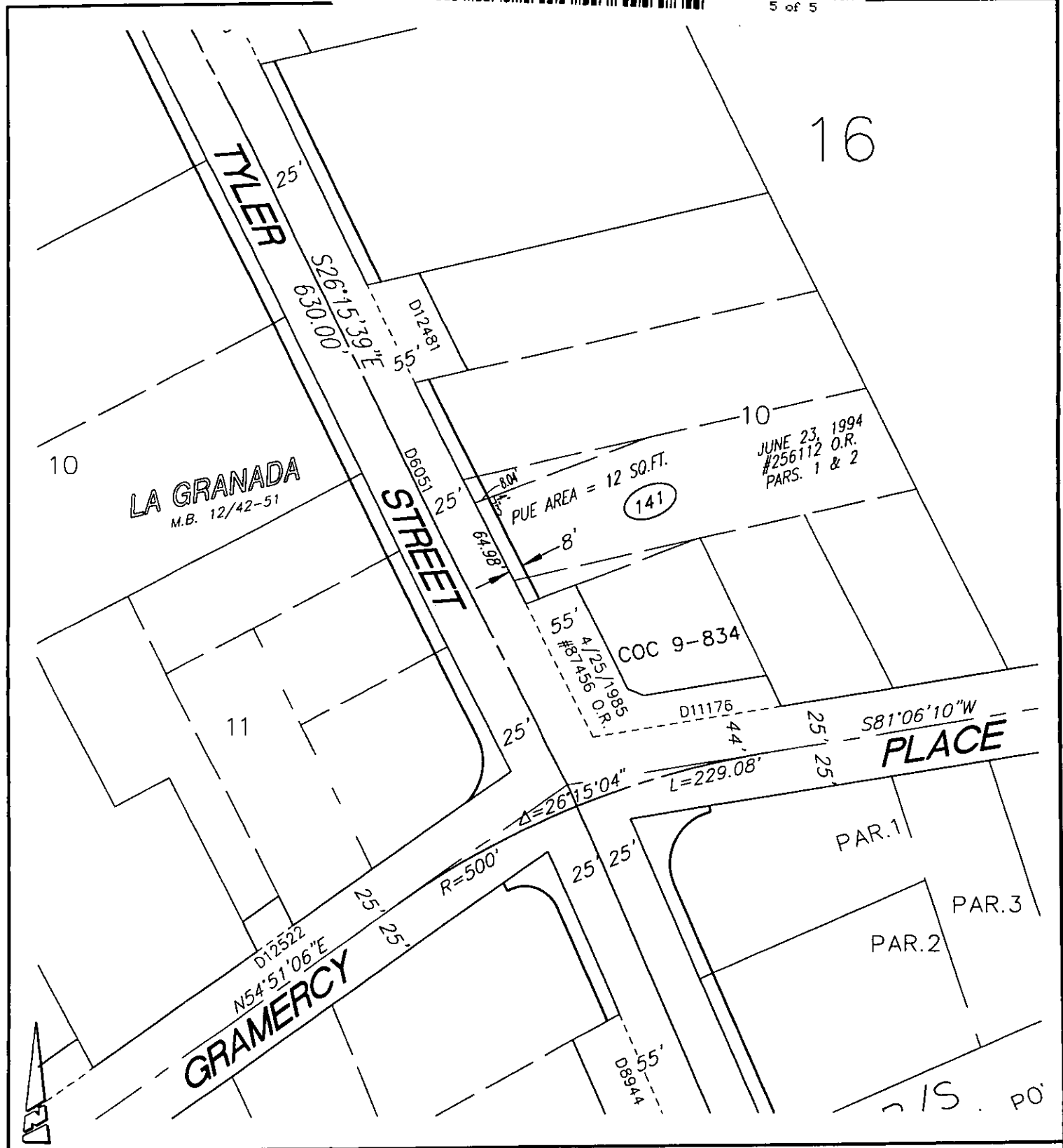
