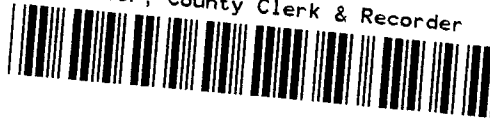

RESOLUTION NO. 21071

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE STREET NAME OF A PORTION OF PETERS STREET BETWEEN MADISON AVENUE AND ESPARANZA STREET TO YSMAEL VILLEGAS STREET.

WHEREAS, an application was submitted by Martha Diaz requesting a street name change of a portion of Peters Street, between Madison Avenue and Esparanza Street, to Ysmael Villegas Street, to honor Medal of Honor recipient Ysmael Villegas; and

WHEREAS, the Planning Commission considered Case P05-0443 at a public hearing held August 4, 2005 and approved the street name change of a portion of Peters Street, between Madison Avenue and Esparanza Street to Ysmael Villegas Street, and forwarded its recommendation to the City Council; and

WHEREAS, on November 15, 2005, the City Council held a public hearing and after considering all of the testimony both written and oral, approved the name change;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California as follows:

Section 1: That portion of Peters Street between Madison and Esparanza Street as shown on the map in the attached Exhibit "A", and incorporated herein by reference, is hereby changed to Ysmael Villegas Street.

Section 2: The City Clerk of the City of Riverside is hereby authorized and directed to cause a certified copy of this Resolution to be recorded in the office of the County Recorder of Riverside County, California.

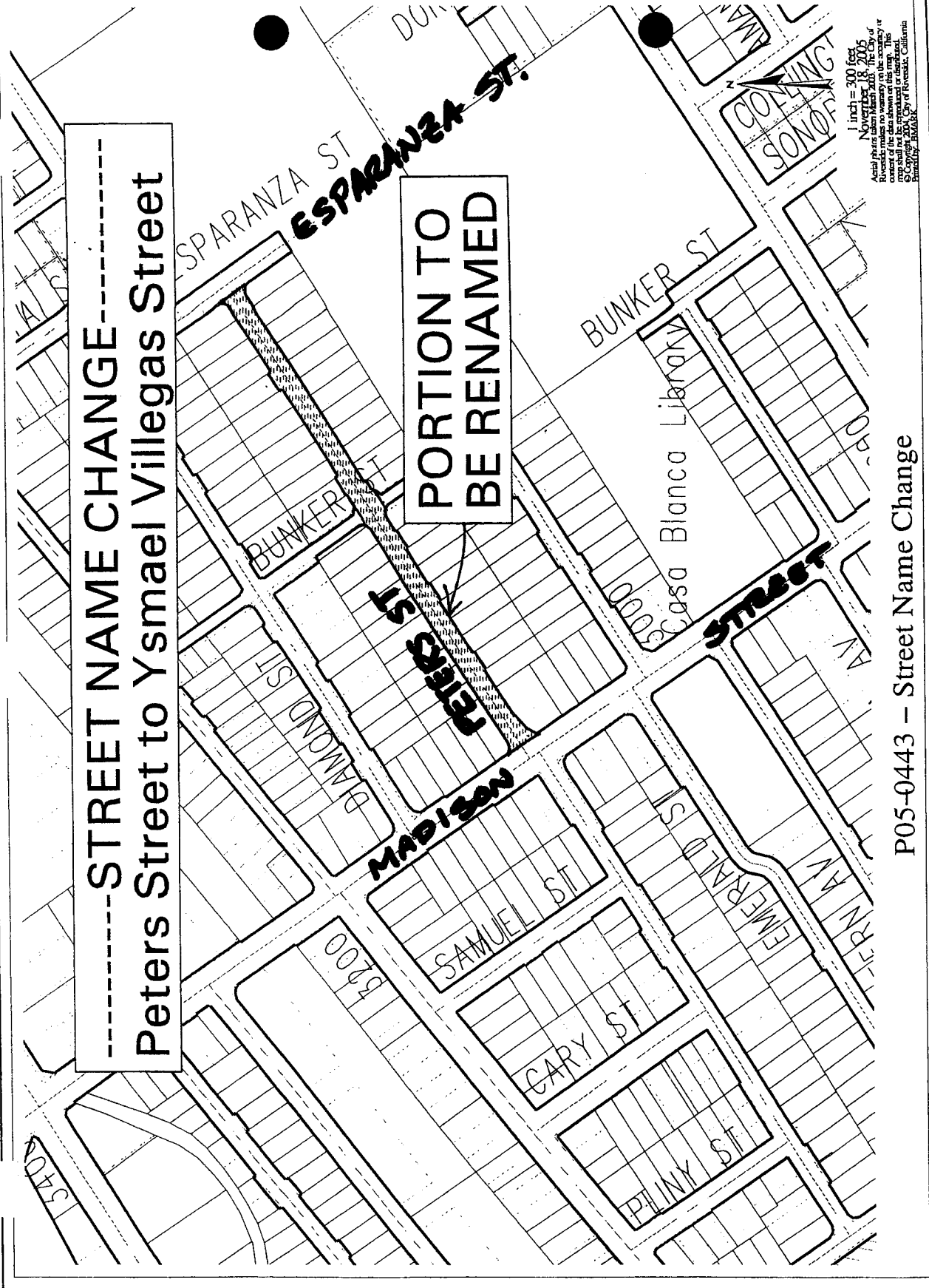
