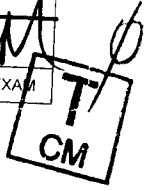



THENCE South 63°08'18" West a distance of 6.04 feet;

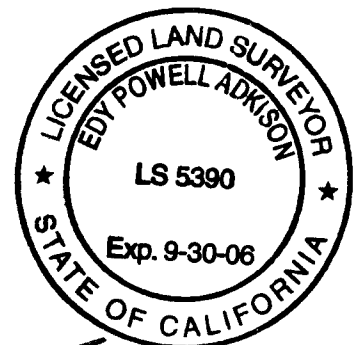

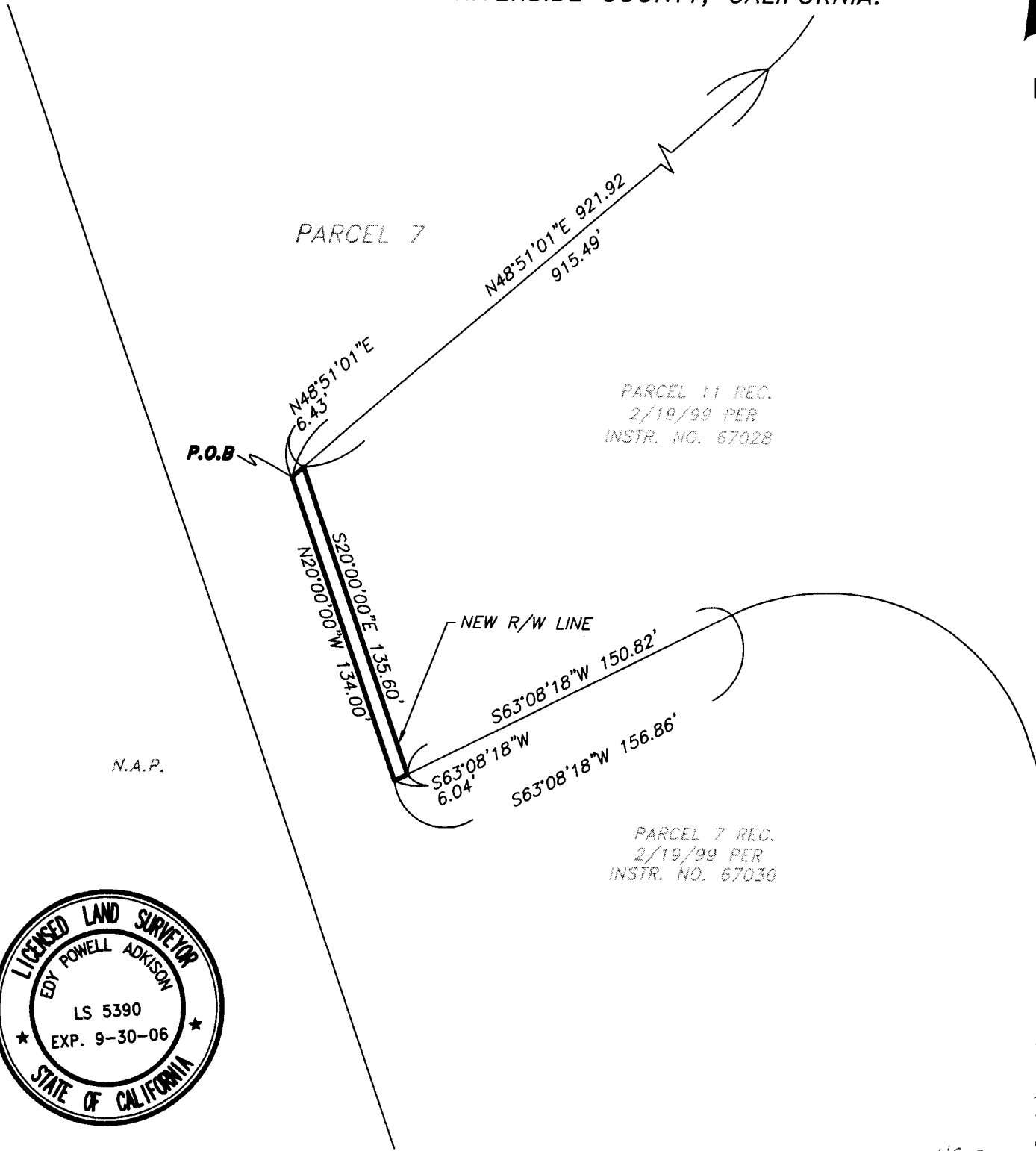
